



# Participant Responsibility

## Waiver

The Wilmerding Community Center has taken great strides in Member Safety during the Covid-19 Pandemic and will continue to keep our facility safe for everyone to enjoy a Healthy and Active Lifestyle. With that in mind, we ask that you read and sign this Member Responsibility Waiver. This lets us know that you are aware of the rules here at the WCC and will continue to help us provide a safe and healthy environment for all. Together we can make a difference!

1. I agree to take my temperature upon entering the WCC. By doing so I am stating that at the time of my entry into the facility I am not currently showing any signs or symptoms of illness and have not had exposure to anyone diagnosed with the Covid-19 virus.
2. I understand that face masks are not optional. The WCC has asked for all members to wear a face mask over our noses and chins as per the CDC guidelines while in the facility.
  - a. **Pool:** I am aware that while I do not have to wear a mask while swimming in the pool, properly worn face coverings are required from the locker room up to the pool and from the pool down to the locker rooms.
  - b. **Classes:** I am aware that while I do not have to wear a mask while I am actively participating in any fitness workout classes, properly worn face coverings are required up until the class starts and immediately after the class finishes.
  - c. **Fitness Center:** I am aware that while I do not have to wear a mask while I am actively using any of the cardio equipment or weight equipment, when I step off of or away from the machine for any reason (to get sanitizer, to change machines, to get a drink) my properly worn face covering must be worn. This is to help protect the other members that are engaging in active workouts. Circuit training is discouraged during the pandemic because it breaks the sanitizing rules.
3. I know that in order to help keep the WCC a safe and healthy place for myself and my community I will correct any facial covering and distancing compliance that is addressed to me by any member of the WCC staff and my fellow members. We are all in this together and I know that by following the CDC Guidelines that the WCC enforces it will help stop the spread and keep a healthy environment for me to work out in.
4. I understand that the use of lockers is very important to help keep any area free from debris and potential germs. While I am at the WCC I will keep all my belongings in a locker or hung up for safety.
5. Knowing how serious this pandemic has become and how hard the WCC has worked to keep me, my loved ones and my community safe and healthy I understand the importance of sanitizing and social distancing.
  - a. I understand that I have to clean any equipment and machines before AND after I use them with the WCC provided, CDC approved sanitizer **before** I use another machine or equipment.
6. I agree that the WCC has every right to expect my full compliance during these unprecedented and uncertain times. I understand that it is my duty to make sure I am following all of the small, but very needed mandates to help keep everyone safe.
7. I understand that there could be repercussions for not adhering to these items, and I will fully accept them should I be told I am not in compliance and refuse to immediately and permanently correct the situation.
