

TINNEY'S PAINTING LIMITED WORKMANSHIP WARRANTY

- ▶ **Exterior:** for a period of 36 months, starting the day of completion of the original project.
- ▶ **Interior:** for a period of 24 months, starting the day of completion of the original project.

Though subject to limitations below, Tinney's Painting will repair any portion of the project that was described in the original accepted estimate that fails due to workmanship and falls within the warranty time frame specified above. Examples, not limited to, chipping, cracking, peeling, or blistering.

The product/material may have a warranty that exceeds the workmanship warranty offered by Tinney's Painting. Product failures are not to be considered workmanship failures. Tinney's Painting will facilitate a project viewing with a manufacturer's representative to determine if the issue falls under the manufacturer's warranty and the proper course of action.

This painting warranty is limited to workmanship. Both our interior and exterior paint warranty cover painting defects, but they do not cover areas of fading and/or damage due to normal wear and tear, abuse, weather, or accidental damaging occurrences. Repairs under this limited warranty will be performed only on the specific areas where the workmanship issue has occurred.

Note: Severe paint blistering and separation of caulk from wood cupping due to intense and/or direct heat are not issues of workmanship and are not covered under the warranty.

THIS LIMITED WARRANTY DOES NOT COVER:

- Any work where Tinney's Painting did not supply the paint or other materials.
- Any work which was not performed by Tinney's Painting.
- Varnished surfaces, specialty finishes (faux work etc.), stained exterior doors and stained exterior wood surfaces.
- Surfaces made of, or containing, galvanized metal.
- Repairs to horizontal surfaces or any surface that, by virtue of its design permits moisture to collect. Surfaces include, but are not limited to, decks, railings, stairs, porches, roofs, and gutters.
- Exact paint match as environmental conditions (intense sun and heat) will affect the color and finish of all paints over time.
- Any repairs which are necessitated as a result of a defect in the paint regardless of whether the paint was supplied by Tinney's Painting or the customer.
- Bleeding caused by knots, rust, or cedar.
- Cracks in drywall, plaster, or wood.

TINNEY'S PAINTING LIMITED WORKMANSHIP WARRANTY

- Peeling, blistering or chipping where they are caused by the following: Ordinary wear and tear; abnormal use or misuse; mill-glazing from smooth cedar; peeling of layers of paint existing prior to the work performed by Tinney's Painting; structural defects; settling or movement; moisture content of the substrate; abrasion, mechanical damage, abrasive cleaning, abuse, or damage resulting from use of chemicals or cleaning agents; exposure to harmful solids, liquids, or gases; damage or defects caused in whole or in part by reason of fire, explosion, flood, acts of God, extreme weather conditions, misuse, alterations, abuse, vandalism, negligence, or any other similar causes beyond the control of Tinney's Painting.

Repairs under this limited warranty will be performed only on the specific areas where peeling, blistering or chipping has occurred and only to the level of surface preparation described in the original invoice.

TO OBTAIN THIS WARRANTY YOU MUST:

- Have paid the original contract price in full.
- Attend a walk through to determine liability with management from Tinney's Painting.
- Make the property accessible to Tinney's Painting to make the repairs.

THIS LIMITED WARRANTY IS THE ONLY EXPRESS WARRANTY MADE BY TINNEY'S PAINTING AND IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED. THIS WARRANTY COVERS ONLY THOSE SERVICES PROVIDED BY TINNEY'S PAINTING TO THE ORIGINAL PURCHASER NAMED ON THE FRONT OF THE ORIGINAL INVOICE. IN NO EVENT SHALL TINNEY'S PAINTING BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES OR DAMAGES IN EXCESS OF THE ORIGINAL INVOICE PRICE. THIS WARRANTY MAY NOT BE ALTERED OR EXTENDED FOR ANY PURPOSE UNLESS DONE SO IN WRITING IN A DOCUMENT EXECUTED BY ALL PARTIES AND ATTACHED TO YOUR INVOICE.
