## THIS CERTIFICATE ACKNOWLEDGES THAT

CREATIVE ENERGY SOLUTIONS, LLC hereby offers the following limited warranty on any commercial air conditioning or refrigeration compressor in which Cold-Plus® is installed. If, within the warranty period and warranty terms set forth below, a commercial air conditioning or refrigeration compressor fails for any reason, except for acts of God, CREATIVE ENERGY SOLUTIONS, LLC will replace the compressor with a new comparable compressor at no charge to the customer. All labor, parts and shipping costs to install the compressor are covered by this limited warranty.

For all R-22 units, the warranty period for the compressor is Three (3) years from the date of Cold-Plus & installation for a new commercial R-22 refrigerant air conditioning or refrigeration unit. If Cold-Plus & is installed in a used commercial oir conditioning or refrigeration unit, and the used unit is in good working order as attested to by a licensed HVAC contractor at the date of Cold-Plus & installation, the limited warranty shall be the number of years remaining after the age of the unit has been subtracted from Fourteen (14). Example: a Seven (7) year old commercial R-22 refrigerant air conditioning or refrigeration unit in good working order will have a Two (2) year limited warranty on the compressor for years thirteen and fourteen.

For all 410A units, the warranty period for the compressor is Three (3) years from the date of Cold-Plus & installation for a new commercial 410-A refrigerant air conditioning or refrigeration unit. If Cold-Plus is installed in a used commercial air conditioning or refrigeration unit, and the used unit is in good working order as attested to by a licensed HVAC contractor at the date of Cold-Plus & installation, the limited warranty shall be the number of years remaining after the age of the unit has been subtracted from Eleven (11). Example: an Eight (8) year old commercial 410-A refrigerant air conditioning or refrigeration unit in good working order will have a Three (3) year limited warranty on the compressor for years ten and eleven.

A Nine (9) year old commercial 410-A refrigerant air conditioning or refrigeration unit in good working order will have a Two (2) year limited warranty on the compressor for years ten and eleven.

Commercial Chillers are one-year parts and labor, regardless of the age of the unit.

All R-32 units 14 (Fourteen) years, and older, receive a 1-year parts, labor and shipping replacement warranty on the compressor.

All 410A units 11 (Eleven) years, and older, receive a 1-year parts, labor and shipping replacement warranty on the compressor.

A 100% Satisfaction Guarantee: the manufacturer of Cold-Plus E, Solid Start, Inc., hereby offers a guarantee of one-year complete satisfaction or a full money back refund.
