If, within the warranty period and warranty terms set forth below, a commercial mobile refrigeration compressor fails for any reason, except for acts of God or vehicle collisions, CREATIVE ENERGY SOLUTIONS, LLC will replace the compressor with a new comparable compressor at no charge to the customer. All labor, parts and shipping costs to install the compressor are covered by this limited warranty. This limited warranty is for the commercial mobile refrigeration compressor only.

For all new mobile refrigeration units, the warranty period is Ten Thousand (10,000) Hours of run time from the date Cold-Plus® is installed. For all used mobile refrigeration units with less than Ten Thousand (10,000) Hours of run time, the warranty period is Two Thousand (2,000) Hours of run time, up to Ten Thousand (10,000) Hours. Examples: If a used commercial mobile refrigeration unit has Seven Thousand (7,000) Hours of run time, the warranty is for an additional Two Thousand (2,000) Hours, up to Nine Thousand (9,000) Hours. If the used commercial mobile refrigeration unit has Eight Thousand Five Hundred (8,500) Hours of run time, the warranty is for an additional One Thousand Five Hundred (1,500) Hours, up to Ten Thousand (10,000) Hours.

All commercial mobile refrigeration units with more than Ten Thousand (10,000) Hours of run time receive a One Thousand (1,000) Hour run time limited warranty on the compressor.

For this warranty to be effective, Cold-Plus® must be installed by a service technician with an EPA Clean Air Section 608, Level 2, certification. The service technician must attest that the unit was in good working condition on the date Cold-Plus® was installed and the attestation must be registered as per the instructions on the back of this warranty certificate.
