## Covenant Rules on Fencing

No wall, fence, or hedge shall be erected or grown nearer the front line of the lot than the rear of the house line. All fences shall be a split rail, Kentucky Board, wrought Iron, or picket design and made of wood Iron or vinyl. The fence may have a mesh wire liner on the inside of the fence only. All fences, wall. Or hedges shall not exceed five feet in height. No privacy fence shall exceed twenty-four feet in length nor exceed eight feet in height. Wood or vinyl privacy fences must match the decor of the exterior of the house by the use of paints, stains, or vinyl (must be colors that match the color schemes of the homes in the community). All fences, walls, and hedges must be placed on owner's side of property line.
