Before the DOF June 2025 Convention in Melbourne, our VAVS Report is due. Therefore, I need your VAVS hours and monetary contributions.



QR Code Fraud

Wednesday, April 30th, 2025 Jacksonville International Airport ("JIA") Chilis Restaurant Jacksonville, FL



QR code fraud, also known as squishing, occurs when scammers replace legitimate QR codes with malicious ones, directing users to fake websites, phishing sites, or prompting the download of malware. These fraudulent codes can lead to the theft of personal and financial information.

How QR Code Fraud Works:

Tampered QR Codes

Scammers may replace or stick stickers with their own QR codes on legitimate ones in public places like restaurants, parking meters, and posters.

My story: If you have ever traveled through JIA and had enough layover time to catch a meal in its food court, beware of the above warning — it happened to me.

Chilis at JIA has QR codes on all of its tables whereby you can view the menu and thereafter pay your bill. After scanning the QR code to pay my Bill, the waitress said that it did not registered, confused I opted to pay with my Credit Card.

Days later and about every few days thereafter I was notified that my Credit Card was being charged \$39.(?) I had my card provider block this fraudulent charge, but I still needed this card due to being out of the country.

I just wanted to share this sad story to warn you about these QR Code scammers.




