## 2020 Level 1 Coaching Enhancement Grant

**National Youth Track Coaches Association** is pleased to offer the following grants for the 2020 year to assist coaches in an opportunity to enhance their professional growth. An application within the stated timeline is required of interested candidates. The Level 1 course is the cornerstone of the USATF Coaching Education Program. It establishes a common ground amongst coaches by developing a language specific to the track and field coaching community. The program covers all events in a straightforward manner by emphasizing fundamentals, rules, safety/risk management, and instruction techniques. Certified by the National Council for Accreditation of Coaching Education (NCACE), the course prepares an individual to coach at the junior high school, high school, club, and junior age division level.

**Grant: Five (5) \$210** grants will be awarded to cover tuition costs. Recipient must pay tuition, attend all sessions and pass exam to be awarded grant for reimbursement.

**Application Deadline: November 2, 2020**

**Notification to recipients: 12 days after the application submitted or deadline.**

**\* All exams must be completed by December 15, 2020.**

**\* Upon passing the exam, participants will be able to download their Level 1 Certificate.**

**\* Exam must be completed and reimbursement documentation submitted by December 15, 2020.**

**\* Upon passing the exam, participants must send notification of completion/passing.**

**\* Email copy of your receipt/cleared check/credit card confirmation.**

### **Criteria:**

1. Current Member (2020 - must be member 30 days prior to submitting application) of National Youth Track Coaches Association.
2. Must be USATF Member, Background Screen & Safesport.
3. Current youth club coach, and actively coaching athletes who are 19 years or younger.
4. Applicant must include a two-paragraph statement of your goals for attending Level 1 School.
