2024 Level 1 Coaching Enhancement Grant

The National Youth Track Coaches Association is pleased to offer the following grant for the 2024 year to assist coaches in an opportunity to enhance their professional growth. An application within the stated timeline is required of interested candidates. Please send completed application to Ron Williams, NYTCA President at rwilliams.nytca@gmail.com. **Selection and notification to recipients will be made within 14 days after the application is submitted or deadline.**

The USATF Level 1 Program is the cornerstone of the USATF Coaching Education Program and accredited by the [National Council for Accreditation of Coaching Education \(NCACE\)](#). The course prepares an individual to coach at the junior age, high school, and club division level by emphasizing fundamentals, teaching progressions, rules, safety, and risk management. The 22-hour course covers all track & field events and related sports science through a blended learning approach, combining self-paced learning with synchronous instruction.

Grant: Three (3) \$250 grants will be awarded to cover tuition costs. Recipients must pay tuition, attend all sessions, and pass an exam to be awarded a grant for reimbursement.

Application Deadline: November 1, 2024

Notification to recipients: 14 days after the application submitted or deadline.

*** Upon passing the exam, participants will be able to download their Level 1 Certificate.**

*** Exam must be completed, and reimbursement documentation submitted by December 16, 2024.**

*** Upon passing the exam, participants must send notification of completion/passing.**

*** Email copy of your receipt of payment, cleared check, credit card confirmation, etc.**

Criteria:

1. Current Member 2024 - (must be member 30 days prior to submitting application) of National Youth Track Coaches Association.
2. Must be USATF Member, Background Screen & Safesport.
3. Current youth club coach, and actively coaching athletes who are 18 years or younger.
4. Applicants must include a two-paragraph statement of your goals for attending Level 1 School.
