## SEASON TICKET APPLICATION 2024-25

# STANDARD TERMS & CONDITIONS

1. The purchase of a season ticket entitles the holder to attend each 1st team home Isthmian South East **LEAGUE** fixture played at Reachfields during the 2024-25 season. Entry to cup matches, friendlies and third party fixtures as well as other events held at the ground are not permitted via the use of the season ticket.
2. Supporters aged 65 or over on 1st August 2024 who are classed as senior concessions and will be entitled to a discounted ticket. Adult season tickets are classed as anyone over the age of 18 on or after the 1<sup>st</sup> August 2024. Children's season tickets are classed as anyone under the age of 18 before the 1<sup>st</sup> August 2024. (Children under the age of 7 will be granted free entry and no season ticket is required) Proof of age must be given in the format of a birth certificate or passport. All prices include VAT at the appropriate rate.
3. For purchases of family season tickets this entitles 2 adults over the age of 18 and 2 children under the age of 18 to gain entry. No admittance will be granted for exchange of a children's ticket(s) for any additional adult tickets or any permutation thereof. Proof of age must be given in the format of a birth certificate or passport. All prices include VAT at the appropriate rate.
4. Season tickets are **NON transferrable**.
5. Transferring a season ticket to a supporter of a visiting team is not permitted. Any supporter who facilitates such an admission to Reachfields is liable to have their season ticket cancelled without compensation.
6. The club cannot guarantee that a match will take place at a particular date/time or venue. The club will make every effort to make supporters aware of any changes to 1st team fixtures.
7. In the event of rescheduling, postponement or abandonment of a match the club will have no liability in respect of season ticket holders who incur consequential loss or damage such as (but not limited to) loss of enjoyment or travel costs.
8. Season tickets remain the property of the football club and must be available for inspection at any time. As such the club reserves the right to cancel or withdraw the season ticket if the holder does not comply with its ground regulations.
9. Should a season ticket be lost and need to be replaced the club will charge **£10.00** for a replacement. This is a non-refundable charge.
10. The club doesn't accept responsibility for stolen cards. Should a card be stolen then it must be reported to the club immediately. Rule 9 will then be applied.
11. It is the responsibility of the season ticket holder to arrive at the stadium on time. Refunds will not be given if a season ticket holder arrives late for a fixture. This includes but is not limited to problems with transport or queuing / entry to the stadium.

12. It is the responsibility of the season ticket holder to inform the club in writing any changes of address/contact numbers or email address.
13. Hythe Tow Football Club reserves the right to withdraw any season ticket and subsequently the season ticket holder for any breach of club, league and FA rules. This will be undertaken with immediate effect until an official hearing has taken place. No refund shall be given in these circumstances.
