Monday–Thursday: 8:00 am– 8:00 pm

Friday: 8:00 am – 10:00 pm

Saturday: 10:00 am–10:00 pm

SNACK SCHEDULE

10:00 AM, 3:00 PM & 8:00 PM

Catered Cost: \$1.75

LUNCH & DINNER SCHEDULE

NOON & 6:00 PM

Catered Cost: \$5.00

Meals and Snacks brought from home must be ready to eat.

For INFANTS and SPECIAL DIETARY NEEDS, clearly written instructions must be provided upon arrival to our staff.

Children arriving in between scheduled snack/meal times will be required to wait until the next scheduled snack/meal time.

Any child that has been in our care for at least three hours must be offered a meal or snack in accordance with State Minimum Standard Rule §746.3301.

QUIET TIMES

1:00 PM – 2:30 PM

We provide a quiet time for those who may need to sleep. Children aged 18 months and older may watch a children's video or participate in a quiet activity.

Kid Space provides rest mats. You may bring a blanket or pillow from home.

ADDITIONAL POLICIES

We do NOT administer medication except asthma inhalers & epi-pens.

Our staff is trained in CPR, SIDS, and First Aid.

Sick children will not be admitted. If your child becomes ill while in our care, we will separate them from others, and call you to pick them up immediately.

Payment is due the same day services are rendered. A \$10 late payment fee will be added to all outstanding balances. Returned checks will incur a \$35.00 fee.

PREPAY POLICY

Pre-payment will be required for the total estimated stay, then either credit or charge for the difference upon return
