THE ADOPTER AGREES:

1. The adopted cat is to live in a private residence as a companion animal and kept inside.
2. To provide the cat with sufficient quantity of nutritious food and fresh water each day.
3. Never to strike or otherwise harm the cat.
4. Allow the cat time to adjust to his/her new surroundings before considering to declaw as it may not be necessary.
5. To spay or neuter the cat by six months of age if not already spayed/neutered at time of adoption. If the cat has not already been spayed or neutered prior to adoption, proof of surgery must be mailed to the original caregiver.
6. To ensure that the cat's vaccinations are current and to provide veterinary care upon illness, disease or injury.
7. To give the original caregiver visitation rights to ensure that the terms of this adoption agreement is being observed.
8. If the cat must be relinquished for any reason by the adopter, he/she must first contact the original caregiver, Star's Cat Connection, who will then have the option to reclaim the cat.

HEALTH OF ADOPTED CAT & INTRODUCTION TO NEW HOME

Cat health is NOT guaranteed. We will provide adopters with any past health problems that we are aware of with the above-described cat(s). Post adoption health issues are adopter's responsibility. We expect that the adopted cat will be taken to a vet if any serious health issue arises as noted in #6 above. We are available for consultation by phone but do not wait on our response if a serious issue arises. Please take the cat to a vet.

We expect all adopters to have a space in the home for the cat to become comfortable with new surroundings and new people before allowing them to free roam the entire home and provide a very slow introduction as necessary with other pets already residing in the home.

RETURNS & REFUNDS

Refunds of any adoption fees will be at the discretion of the original caregiver, Star's Cat Connection.

AGREEMENT, PAYMENT, & SIGNATURES

I (the adopter) agree that the failure to follow the above agreement will constitute a breach of contract, and the original caregiver, Star's Cat Connection, has the right to repossession of the adopted cat.
