## PROCEDURE FOR OBTAINING A PERMIT TO HUNT FROM A BLIND

A permit to hunt from a blind in Zone 'A' must be obtained whether or not the hunter has a reservation.

# WITHOUT RESERVATIONS— FIRST COME, FIRST SERVED

(a) Hunters arriving at the Unit Office should park their vehicles in order of arrival, in the designated parking lot. The first vehicle will take position #1, the second will take position #2, etc. Signs at the parking lot will indicate the positions. **The cars must be occupied at all times by the** hunters.

(b) Numbered arrival cards will be distributed to the hunters in the vehicles in order that blinds may be choosen in order of arrival. Hunters in car #1 will have a choice from all the blinds, those in #2 a choice from all those remaining etc. One blind will be allotted per one or two hunters per vehicle or two blinds per three or four hunters per vehicle.

(c) The Unit Office should be entered after a number card has been received in the parking lot. Hunters arriving after the office opens will receive a registration card inside.

(d) Registration cards will be filled in showing name, address and the Ontario and Federal Hunting Licence numbers. Hunters should be prepared to choose their blind quickly by referring to the map of the unit and to the registration board which indicates which blinds are already occupied.

(e) The Ontario and Federal Hunting Licences will be deposited with the registrar when signing in for a blind. They will be returned upon checking out from the unit.

## **PERMITS FOR ENTRY INTO PARK:**

— Anyone arriving **prior** to hunting day (day starts one second after midnight) will be charged the regular vehicle entry fee, if they wish to stay in parking lot. If hunter wants to use campground and associated facilities, they will pay the regular camping fee.

— Anyone arriving after midnight on the hunting day and vacating the park on the same hunting day will not require any additional permits other than his/her blind permit.

#### **RESERVATIONS:**

In order that hunters coming from distant points will have the assurance of obtaining a blind for a specific day, reservations for a limited number of blinds (8), will be accepted.

## A ZONE BOUNDARY LINE:

— Will not constitute a fixed or legal boundary, but is only an indication for A Zone blind hunter protection. Therefore no B Zone hunting allowed beyond line of indication.

#### **HUNTING DAYS:**

 Monday, Wednesday, Friday and Saturday of any week during the regular open season.

## **HUNTING HOURS:**

 One-half hour before sunrise to one-half hour after sunset.

#### FEES:

— A Zone (Daily blind licence) \$8.00 per blind per day, for one or two hunters.

- B Zone (Seasonal licence) \$8.00 per hunter.

#### **BLINDS:**

— A Zone — supplied by the Ministry of Natural Resources. No others may be erected or used. No hunting is allowed outside the blind. (There is a maximum of two hunters per blind.)

— B Zone — No blinds are supplied. If you wish to erect a blind you are required to obtain a licence in Form 7. This licence is available at the Unit Office.

#### GAME:

Ducks, geese, rails, coots, gallinules only.
NO OTHER BIRDS OR ANIMALS MAY BE SHOT.

#### **RECORDS:**

— A Zone — All hunters are required to submit records to the Unit Office at the end of the day's hunt of the hunting hours, birds bagged, birds lost or crippled.

- B Zone - All hunters are asked to submit records at the end of the season of hunting hours, birds bagged (species and numbers) and birds lost or crippled.

## **FIREARMS:**

— Must be encased or dismantled at all times except when at a designated blind. Only shotguns may be used and must be permanently plugged or altered so that it is incapable of holding a total of more than three shells at one time in the chamber and magazine.

## **BOATS, MOTORS:**

- or other equipment are not supplied. Local marinas usually provide this service.

## **DECOYS:**

- Not supplied.

## **GENERAL RULES:**

 i) Dogs are a great asset in retrieving downed birds but must be leashed and under control at all times except when at a designated blind location.
ii) No alcoholic beverages to be consumed other than on a valid campsite.
