TCP Readiness Update





RPP (Release Prior to Payment Privilege) - Ongoing Issue

What is the plan for R2?

Process mapping and overview required for financial instruments

How will bond/financial security information be loaded in the portal and by whom?

- Communication requires updating to eliminate conflicting information on the use of financial instruments; not limited to cash and surety bonds. Reference applicable D Memo, etc.
- Payment In Progress CBSA has reached out to TCP's and we owe information and time to discuss

R1 - May 25, 2021

• Status update to include uptake numbers, onboarding challenges (i.e. notifications not working). **Standing request to** add number of bonds/financial security secured.

When can we expect to see the dashboards updated and provided to TCP's?

• Rulings module has visibility issue. Brokers/consultants losing access/visibility to original submissions and subsequent decisions of CBSA.

Requested confirmation and resolution January 23rd TCP meeting. When can TCP's expect resolution on this issue?

- Status update of ARL clean up and the number of accounts yet to be reconciled.
- Members of the TCP expressed concerns as it pertains to the Minister of Public Safety briefing on the CARM project and when can we expect the political authority to be in place to make a formal announcement and revised implementation strategy? Lack of clarity is creating A LOT of confusion for TCP's and conflicting information in the marketplace.

Technical Support – June 23, 2021

- What version of ECCRD is out and what are the plans for communicating revisions. Need a complete ECCRD with addendums capturing all revisions.
- CSA importers significantly impacted under CARM with eliminating X type entries and will not be in a position to the R2 go live date due to insufficient lead time to implement major changes.

When can TCP's expect to receive a <u>complete</u> ECCRD?

Inaccurate use cases in the ECCRD have been identified and require correction.

What is the ETA to accomplish this?

Regulatory Package-Outstanding Issue

 Respecting "Cabinet Confidence" industry need to have visibility and understanding of the main components of these changes including timelines.

Is there are way forward to share?

Data Matrix/CAD Still pending – In Discussion to plan session

- Need comprehensive review of data elements. WCO data elements level set understanding.
- CAD not feasible as presented.

Is there an update on potential revision?

CBSA Coordination Ongoing Challenge

- working collaboratively to schedule meetings over the next couple of months on specific topics/scenarios and a CBSA Subject Matter Expert(s) participate. External consultants are welcome to participate as observers.
- Better oversight in scheduling meetings to ensure no conflict with other proprietary meetings with CBSA and/or industry events and large scale projects.

Is there an update on coordinated efforts for future planning?

Operational Workflow – Work in Progress – New Additions

- Walkthrough of real scenarios. <u>Standing request since 2011</u>. Requirement to prioritize completion date as this impacts solution and TCP understanding of end state.
- A few scenarios presented to date and we acknowledge some progress.

- Provide option for carrier/broker to submit line item details with transmission to eliminate need to provide recap. How is the subset recap submitted? New
- API Limitations (Exchange Rate and Tariff) New
 How will TCP's access? Identify limitation on returns and queries.
- Status update for Temporary imports (registered trade shows New

Enterprise Risk & Corporate Security- NEW

Industry concerns utilizing AWS platform and not a government cloud farm.

How can CBSA ensure protection of data?

Playbook required outlining how the agency and Deloitte will manage Enterprise Risk and Corporate Security.

Client Experience Simulation -NEW

CARM PORTAL – NEW

• Portal affinity questions are cumbersome and difficult to provide the right response when there is more than one broker or the AR remains unreconciled.

Why is there another level of authorization required outside of the GAA between the broker and importer to work with CBSA to establish the CARM client portal?

- *Playbook required for CARM portal*; portal screenshots and associated detail with how to use those screens. Illustrating cancelled CAD's, BCN changes etc.,
- Delegation of authority concerns over the way the delegation is granted and cannot be segmented ie importer chooses to only provide customs broker authority to submit a CAD.







Testing Overview





Purpose

- Provide an overview of R2 testing activities leading up to R2 go-live
- Explain objectives for the different test types



Build & Unit Testing -- Completed

- Testing started during the solution build phase, when applications and environments were being prepared through configuration and development work to meet the business requirements defined during the Design phase.
- During this phase, the CARM Solution Design Development teams conducted the technical unit testing and the CARM Solution Design Functional Teams completed the functional unit testing (FUT), aka string testing.

System Integration Testing (SIT) - Completed

- End to end business processes were tested by the project team through sequences of test scenarios and test cases.
- System Integration Testing had three cycles (SIT1, SIT2 and SIT3), each with different scope and increasing complexity.



Performance Testing – In progress

- Is currently being executed in an environment that has the configuration hardware/setup configuration and data as close as possible to that of production to ensure the system's underlying technical architecture and processes are working at the SLA performance metrics defined in conjunction with CBSA.
- Testing includes transactions and background processes and will simulate application load using virtual users and transaction load.

Penetration Testing – Completed

 Pen testing aims at discovering vulnerabilities that may have been missed by other technologies used in our security testing approach. It focuses on non-standard exploitation and tries to leverage weaknesses in the defined business process to impact the confidentiality, integrity or availability of the data.

- Operations Testing (Failover and Disaster Recovery Testing) Part of Managed Services for production system, not part of the R2 project
 - Will confirm the expected behaviors of infrastructure during outage events, disaster recovery situations, error events and monitoring events.
- User Acceptance Testing (UAT) In progress
 - Comprehensive testing of the CARM solution by CBSA, leveraging the "a day in the life / a week" of business user type of scenarios emulating R2 business processes, and will confirm the solution meets the CARM business requirements.
- Regression Testing In progress and upcoming
 - Will be performed throughout the testing cycles, using automated test scripts, where applicable, to ensure that the CARM Solution has not affected pre-existing functionality.
 - A dedicated regression test cycle will be executed close to go live.



TCP Deep Cycle Testing – In progress

 Validate with a select set of TCPs that the solution and integration between CARM and TCP systems works correctly end to end.

TCP Certification – Upcoming


- Will be performed to validate that TCPs who currently interact with the Agency electronically can continue to do so.
- This will also be a process for TCPs that sign up for electronic submission post go-live.

Mock Cutovers – In progress

- Testing of the processes to move from the current systems to CARM R2 at the go-live.
- This includes data conversion testing, manual and automated steps to be executed as part of go-live.



Release 2 – Test Activities Timeline (not to scale)












Trade Chain Partner Portal Onboarding Status


Importer registration anticipated to continually grow as CARM onboarding webinars continue in 2022.





- With continued high attendance, onboarding webinars will continue until at least April 2022.
- Every week, there are 400-500 new TCPs registering to the CARM Client Portal.





Key Notes and Assumptions:

- Top 30 Brokers (byvalue) make up > 80% of Total Broker Accounts Receivable (A/R) Value. Top 3000 Importers (value) make up > 80% of Total Importer A/R.
- Top 30 Brokers make up > 80% of Total Broker Volume and Top 3000 Importers make up 79% of Total Importer Volume.
- * Monthly average did not include December 27th to January 3rd as it was a holiday period with 28 registration.

CARM Experience Simulation (CES) Proposal





Purpose

- Introduce the CARM Experience Simulation concept
- Outline initial expectations of participating Trade Chain Partners
- Discuss the approach to identify and confirm participation
- Communicate next steps



CARM Experience Simulation (CES)

What?

- Opportunity for a sample of representative Trade Chain Partners (TCPs) and CBSA business users to experience the high risk and complex business processes and system changes that CARM will implement in R2.
- Users will be able to explore simulated end-to-end, real-life scenarios to familiarize themselves with the target state processes and system.



- Engage "hands on" in CARM
- Strengthen and inform readiness activities
- Build confidence in solution and processes (CBSA and TCPs)
- Identify potential improvements



How?

- TCPs onboarded to CARM simulation environment in advance
- Simulation scenarios executed by TCP participants through a series of ~ 4 week sprints organized around TCP groupings with CBSA support (including training)
- Assess confidence at the start, work through the simulations & provide feedback, assess confidence at the end
- Share findings with the TCP Working Group and as key additional input to prepare for full launch



To be confirmed – currently targeting to begin in May 2022 through to October 2022 - will be sequenced to optimize participation

Scope Boundaries

What IS in Scope

- Practicing the execution of complex and high risk business processes and associated enabling solution components in an end-to-end fashion
- Identification of suggestions to improve CARM (system and supports)
- Depersonalized/fictitious data
- Include both volumes and commodities representative of existing environment
- 5. Include CSA and CLVS transactions
- 6. Simulated time lapses for time dependant processes
- 7. Communication and training for participants
- 8. Client and end user support

What is NOT in Scope

- Not an open sandbox
- 2. Not supporting an unlimited number of participants
- 3. Will not focus on processes/capabilities deployed in R0 and R1
- 4. Registration and Temporary Importation processes*
- 5. Active production transaction data and activity (looking to take a copy and mask data)
- Integration points with non-CARM CBSA and OGD systems
- 7. Transfer of payment or commitment against posted bond
- 8. Commitment to implement suggested system changes prior to R2 implementation**



Processes for Inclusion in the CES

CARM enables 17 core processes that facilitate the accounting, collection of duties and taxes, and compliance of commercial goods released into Canada. Release 2 encompasses the 13 fully implemented core-CARM processes presented below



- For the simulation, we are proposing to include the 13 new Release 2 processes with the following refinements:
- ADD Warehouse Inventory
- Proposing NOT to include:
 - Register Client: Participants will already be registered
 - Manage Temporary Importations: Avoid need to simulate in-person visit to POE



Expectations



- TCPs who are keen to participate, learn and help prepare to deliver CARM successfully
- TCPs who are viewed as influencers in helping to build confidence in advance of full implementation
- Variety of representative TCPs
- It is expected that TCPs will be required to sign a "waiver" acknowledging how data will be used, and that the simulation is for experience purposes only the transactions/interactions are not binding
- Participants must agree to share results of the simulation with CBSA and TCP WG,
- Will participate in surveys and feedback processes throughout their involvement in the simulation.
- Complete CARM Client Portal registration (including any required delegation of authority), ideally by April,
 2022
- Be ready to test EDI and/or API connectivity (if applicable) between May and October, 2022



 Capacity to be dedicated to the experience simulation including a dedicated simulation team, client support and "model office" representing implicated CARM business process areas in order to simulate the end-to-end experience



- Combination of pre-seeded data (where needed) and TCP "in the moment" data to simulate the experience
- Ability to "explore", within boundaries where there are CBSA back-end manual processes

Key Working Assumptions

- Any escalated technical issues/problems will be addressed by the CARM solution team. The full Managed Services environment for R2 will not be activated
- Confidentiality of broker/importer relationships will be maintained
