RESOLUTION NO. 24-36 A RESOLUTION OF NECESSITY TO LEVY A TAX IN EXCESS OF THE TEN-MILL LIMITATION FOR FIRE, EMERGENCY MEDICAL SERVICES AND POLICE PROTECTION (R.C. §§ 5705.03, 5705.19, 5705.191, and 5705.25)

The Board of Trustees of Washington Township, Clermont County, Ohio, met in regular session on the 5th day of June, 2024 with the following members present:

Dennis Cooper, Trustee

Aaron Maus, Trustee

David Peters, Trustee

Mr. Maus moved for the adoption of the following resolution:

WHEREAS, the amount of taxes that will be raised within the ten-mill limitation will be insufficient to provide for the necessary requirements of Washington Township, Clermont County, Ohio ("Township"); and,

WHEREAS, it is necessary to levy a tax in excess of the ten-mill limitation; and

WHEREAS, the levy would be for the purpose of fire and emergency medical services, and police protection services, said purposes being authorized by R.C. §5705.19 (I) and (J) and R.C. §5705.191; and,

WHEREAS, a resolution declaring the necessity of levying an additional tax upon the electors of the incorporated and unincorporated territory of Washington Township, pursuant to R.C. § 5705.03, outside the ten-mill limitation must be approved and certified to the Clermont County Auditor ("Auditor") in order to permit the Board to consider the levy of such a tax and must request that the Auditor certify to the Board the total current tax valuation of the Township, and the dollar amount of revenue that would be generated by a specified number of mills.

NOW THEREFORE, BE IT RESOLVED, by the Board, at least two-thirds (2/3) of all of the members of the Board concurring, as follows:

SECTION I

That the amount of taxes that will be raised within the ten-mill limitation will be insufficient to provide for the necessary requirements of the Township and it is necessary to levy an additional 2 mills tax in excess of the ten-mill limitation for the benefit of Washington Township as set

SECTION II

That pursuant to the provisions of Section 5705.191 an additional levy in the amount of two (2.0) mills for each One Dollar (\$1.00) of valuation, which amounts to twenty cents (\$.200) per One Hundred Dollars (\$100.00) valuation for a continuous period to be placed on the 2024 tax duplicate for first collection in 2025 and continuing thereafter, for the provision and maintenance of fire apparatus, mechanical resuscitators, underwater

rescue and recovery equipment, or other fire equipment and appliances, buildings and sites therefor, or sources of water supply and materials therefor, for the establishment and maintenance of lines of fire-alarm communications, for the payment of firefighting companies or permanent, part-time, or volunteer firefighting, emergency medical service, administrative, or communications personnel to operate the same, including the payment of any employer contributions required for such personnel under section 145.48 or 742.34 of the Revised Code, for the purchase of ambulance equipment, for the provision of ambulance, paramedic, or other emergency medical services operated by a fire department or firefighting company, or for the payment of other related costs; and for the payment of the costs incurred by townships as a result of contracts made with other political subdivisions in order to obtain police protection.

SECTION III

That the question of the passage of said levy shall be submitted to the electorate of the incorporated and unincorporated territory of Washington Township, at the General Election to be held on November 5, 2024. If approved by the electors, said tax levy shall first be placed upon the 2024 tax list and duplicate, for first collection in calendar year 2025.

SECTION IV

That pursuant to Section 5705.03 of the Ohio Revised Code, the county auditor is hereby requested to certify to this Board of Trustees of Washington Township, the total current tax valuation of the Township and the dollar amount of revenues that would be generated by the number of mills specified in Section II hereof, and the Fiscal Officer of Washington Township be and is hereby directed to certify forthwith a copy of this resolution to the county auditor at the earliest possible time so the said county auditor may certify such matters in accordance with Section 5705.03.

SECTION V

That the tax is to be levied on the incorporated and unincorporated the territory of Washington Township, which is located entirely within Clermont County, Ohio.

SECTION VI

That the submission of the question of this tax is authorized by Sections 5705.03, 5705.19, 5705.191, and 5705.25 of the Ohio Revised Code.

SECTION VII

That the Board of Trustees of Washington Township hereby finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of the Board and its Committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with all applicable legal requirements including Section 121.22 of the Ohio Revised Code.

New Business

Mr. Peters requested the Board to consider giving raises to the Road and Bridge personnel.
