Volunteer will agree to waive any and all claims for personal injury, purported viral infection and or damages resulting from participating in the sale from whatever cause against REPLAY Pop Up Consignment LLC, Linda Kline (owner), other volunteers, any Insurer, lessors & employees of the space where the sale is held, employees, consignors, or any helpers participating in the sale.

1. Possible Volunteer Duties:

The Volunteer agrees to perform any/all of the following duties assigned: - Assist in setting up the consignment sale venue. - Help with organizing and arranging consignment items. - Operate the check out computer - Be stationed at any of the following areas at the sale -Door Security, Disinfection Station, Inspection Station, Large Ticket Item Area - Provide customer service during the sale. - Assist in the cleanup and dismantling of the venue after the sale. No experience is needed. Instructions will be given before your hours begin.

2. Volunteer Commitment:

The Volunteer agrees to commit to the schedule they have signed up for with our online program. The Volunteer agrees to find a replacement volunteer if they cannot make the shift they scheduled.

3. Volunteer Status:

The Volunteer acknowledges that they are providing services on a voluntary basis and will not receive monetary compensation for their services.

4. Confidentiality:

The Volunteer agrees to maintain the confidentiality of any sensitive information they may come across during their volunteer service.

5. Code of Conduct:

The Volunteer agrees to adhere to the Organization's code of conduct, which includes professionalism, respect for others, and compliance with all applicable laws and regulations.

6. Termination:

Either party may terminate this Agreement at any time by providing written notice to the other party.

7. Governing Law:

Will not sell any items at this sale and will not sell under the consignor they are helping.

Will help a minimum of 4 hours physically at the sale location. 16 Hours is the maximum gift hour limit.

Volunteers must sign in and sign out for hours to be verified.

Will have the option to select additional available hours at the sale.

Will provide any cancellations to the Consignor they are helping **and** REPLAY Pop Up Consignment in an email notification or call as soon as possible.

Will forfeit the gift credit of volunteer hours to the consignor they are helping if you should cancel any hours.

Will perform the selected help shift with NO CHILDREN, NO SHOPPING, NO EXCESSIVE SOCIALIZING.

Volunteer, not consigning or helping another consignor.

Will register as a volunteer on the system site.

Will help a minimum of 4 hours that is physically at the sale location.

Volunteers must sign in and out for hours to be verified.

Will have the option to select additional available hours to reach certain presale hour privileges, up to 16 hours.

Will provide any cancellations to REPLAY Pop Up Consignment in an email notification at replaypopupconsign@gmail.com or call as soon as possible.

Will forfeit the presale pass benefit if you should cancel any help shift.

Will pick up your designated presale pass at the sale before your shopping time

Will perform the selected help shift with NO CHILDREN, NO SHOPPING, NO EXCESSIVE SOCIALIZING.
