Kindly note,

This is to inform you that I personally opposing to your published Canada Gazette, Part I, Volume 155, Number 20: Code of Professional Conduct for College of Immigration and Citizenship Consultants Licensees for the following reason.

We have established a claim against your department for copyright infringement, We are able to prove the following:

1. **copyright** subsists in the work or content in question.
2. We are the owner of the **copyright** in the work or content.
3. the work or content (or elements of it) was **infringed**.

THEREFORE: A cease and desist *letter because* ;

1. You have used titles that is registered under the Intellectual copyright and you have caused infringement.
2. I am enclosing all copyright registrations that forbid your department from using them without my permission .
3. The penalty for copyright infringement in Canada are these primarily deal with **infringement** that involves sale or rental of copyrighted materials, and can result in **fin**es of up to \$1,000,000 or prison sentences of up to 2 years for indictment. For a summary conviction, the maximum **fine** is \$25,000 and prison term is limited to 6 months.

4. All powers to legislate **copyright law** are in the jurisdiction of the Parliament of **Canada** by virtue of section 91(23) of the Constitution Act, 1867.
5. use copyrighted material without permission under Fair **use** allows limited **use** of **copyrighted material without permission** from the **copyright** holder for purposes such as criticism, parody, news reporting, research and scholarship, and teaching, however, this is not in your case as you deliberately infringing on my copyrights.
6. Your department have constituted copyright infringement in Canada and that **Copyright infringement** occurs where your department wrongfully used our work without our permission or does anything only us an owner is allowed to do, as stated in the **Copyright Act** . **Infringement** may include acts such as copying, performing, selling/distributing or posting your work on the internet without our permission.
7. We the owners can give you 48 hours to take down the **copyrighted**-content. If your department not comply by the same, we the owners can submit a **copyright complaint** by filing a lawsuit to forbid you from using these titles again through introductory motion at the federal level.
8. copyright infringement a crime Canada under section 43 (1) Any person who, without the written consent of the owner of the **copyright** or of the legal representative of the owner, knowingly performs or causes to be performed in public and for private profit the whole or any part, constituting an **infringement**, of any dramatic or operatic work or musical composition in

your department is forbidden from using the following titles;
