## **Liability Waiver**

Energy healing, breathwork, and sound may result in physical, mental, and/or emotional discomfort. I VOLUNTARILY ACCEPT FULL RESPONSIBILITY OF ALL RISKS INVOLVED, INCLUDING RISKS FROM PARTICIPATING IN ANY WAY IN THE TRAINING, USE OF EQUIPMENT PROVIDED BY THE TRAINER OR USE OF EQUIPMENT I PROVIDE, WHETHER THE TRAINING OCCURS AT THE STUDIO, MY HOME, OFFICE OR ANY OTHER LOCATION.

WAIVER: In consideration of my participation in the class provided by Christian Correia-Covert I, for myself, my heirs, executors, administrators or assigns, do hereby release, waive, discharge and covenant not to sue Trainer and/or its members, managers, officers, directors, agents, employees, and affiliated entities (Hereinafter referred to as "Releases") from liability, from any and all claims, including the negligence of Christian Correia-Covert resulting in personal injury, accident or illnesses. (Including Death) and property loss arising from, but not limited to, participation in the training and use of facilities, premises or equipment wherever located and by whomever provided. I further acknowledge and agree that I am not obligated to participate in any class that I do not wish to participate in. I will inform Christian Correia-Covert immediately if I do not wish to participate in any specific activity in class.
