

## Riverbend Trading Post Ltd. Liability Waiver

This is a legal document. Please read carefully before signing.

I, the undersigned ("Participant"), wish to access and use the Riverbend Trading Post Ltd. Disc Golf Course and related facilities for recreational activities including, but not limited to, disc golf, hiking, RV camping, sunflower picking, and use of picnic and play areas.

In consideration for being allowed to participate, I agree with the following terms:

1. 1. Assumption of Risk: I acknowledge that outdoor activities involve inherent risks including uneven terrain, weather, wildlife, disc impacts, injury, illness (including communicable diseases like COVID-19), and property damage. I voluntarily assume all risks, known and unknown.
2. 2. Waiver and Release of Liability: I release and discharge Riverbend Trading Post Ltd., its owners, employees, agents, volunteers, officers, directors and contractors (the "Releasees") from any and all liability, claims, demands, actions, or causes of action arising from participation in recreational activities on Riverbend Trading Post Ltd. property whether caused by negligence of the Releasees or otherwise.
3. 3. Indemnity: I agree to indemnify and hold harmless the Releasees from any claims, damages, or expenses arising from my participation in recreational activities on Riverbend Trading Post Ltd. property or my conduct on the premises.
4. 4. Medical Expenses: In case of injury requiring medical attention to treat my injuries, I am responsible for any medical expenses incurred.
5. 5. Photography and Media: I grant permission to Riverbend Trading Post Ltd. to use photos or videos of me taken during my visit when I participate in public events for promotional purposes without compensation being paid to me.
6. 6. Compliance with Rules: I agree to follow all posted rules and verbal instructions. Failure to comply may result in my removal from the Riverbend Trading Post Ltd. facility without refund of any fees paid for participation in recreational activities or site rental.
7. 7. Binding Effect: This waiver is binding upon me, my heirs, executors, administrators, and assigns and ensures to the benefit of the Releasees, Riverbend Trading Post Ltd. and their heirs, administrators, successors and assigns. If any part of this Release is held invalid, the remaining clauses remains in effect.
8. 8. Minors: If this Release is signed on behalf of a minor, I certify that I am the legal parent or guardian of the Minor and agree to the terms of this Release being binding upon him or her. I agree that the minor shall always be under my supervision and control when participating in recreational activities on the premises and that in event of injury to the minor I will save harmless and indemnify the Releasees and Riverbend Trading Post Ltd. for any damages or costs which may be found due and payable to or on behalf of the minor.

I HAVE READ AND UNDERSTAND THIS AGREEMENT. I AM AWARE THAT BY SIGNING THIS DOCUMENT I AM WAIVING CERTAIN LEGAL RIGHTS.
