In consideration of my being allowed to use and enjoy the services, equipment, and facilities of Kwality Venturez LLC & Thrash The Smash Room ("Thrash"), I hereby and acknowledge and agree to the following terms and conditions:

ASSUMPTION OF RISKS: I am aware that Thrash involves unusual risks, dangers and hazards including, but not limited to: the possibility of serious injury or death, resulting from any of the services, equipment, and facilities at Thrash The Smash Room, including without limitation,

- Injuries resulting from the actions or omissions of others, including but not limited to slips, trips
 and falls of other participants and flying debris;
- Cuts and abrasions resulting from skin contact with damaged items, debris, or any other surface, person, or equipment;
- Injuries resulting from shock, stress or another injury;
- The aggravation or worsening of any existing medical condition;
- · Failure or misuse of safety gear, weapons, or any other items or equipment;
- Failure to follow Thrash The Smash Room's employee instructions or failure to ask for information or assistance;

I freely accept and fully assume all such risks, dangers and hazards and the possibility of injury, death, property damage or loss resulting

MEDICAL CONDITION:

I understand that use of Thrash may place unusual stresses on the body. Use of smash rooms are not recommended for persons suffering from asthma, epilepsy, cardio/respiratory disorder, hypertension, or skeletal, joint or ligament problems or conditions, and certain mental illnesses. RELEASE OF LIABILITY, WAIVER OF CLAIMS, AND PROTECTION AGREEMENT:

- 4. This Release Agreement and any rights, duties and obligations as between the parties to this Release Agreement shall be governed by and interpreted solely in accordance with the laws of the state of South Carolina and no other jurisdiction;
- 5. Any litigation involving the parties to this Release Agreement shall be brought solely within the state of South Carolina and shall be within the exclusive jurisdiction of the Courts of South Carolina.
