NARRATIVE

On August 26, the Castro Valley School Board held a meeting that began in closed session at 5:00 PM and convened in open session at 6:00 PM. At 6:02 PM, while the meeting was underway, Superintendent Rashidchi sent me an email concerning a subject I intended to address during public-comment. As public comment was about to begin, Superintendent Rashidchi and School Board President Raymond engaged in a whispered discussion (Image 1). When I was called to the podium to speak, Raymond interrupted my first sentence and stated that I could not speak. Assistant Superintendent Zamora then motioned for me to leave (Image 2). Zamora turned off the microphone. As I turned toward Zamora, I observed a muscular man (John Doe) positioned at my back, out of view of the audience. Doe blocked the nearest exit. His attention remained fixed on me, and I felt threatened by his presence and positioning (Image 3). These actions violated my right to public comment under California Government Code section 54954.3 (the Ralph M. Brown Act), which requires school boards to allow the public to speak. The actions prevented the public from receiving information from me. Government Code section 54959 provides that each member of a legislative body who attends a meeting where action is taken in violation of the Brown Act, and who intends to deprive the public of information, is guilty of a misdemeanor. The relevant elements include: 1. The statute applies to members of the legislative body. The primary actor is President Sara Raymond. 2. Action taken at the meeting: President Raymond directed that I could not speak. 3. Specific intent: The Superintendent's email, sent during the meeting about the subject I meant to raise, shows knowledge of the information, and her whispered discussion with the President indicates an intent to prevent the public from hearing it. Misdemeanors under section 54959 are punishable under Penal Code section 19 by imprisonment of six months, and a fine of 1,000.
