## Savory Sweets Cookie Dough -

I met with the music staff in August to discuss ways to improve sales and ideas for the Neighborhood Blitz. The HS Marching Band will canvas the targeted neighborhoods the week before the actual blitz. They will leave flyers on doors giving details of when they will return to take orders/donations, instructions on how to order/donate if homeowner will not be available during the blitz, and instructions on how homeowners can opt out of the door to door sale. Orchestra and Choir will work the actual blitz. Two neighborhoods will be included this year: the neighborhood around Brent Elementary and the neighborhood across from Whitaker Elementary. Specific streets will be determined later. Prizes will be given in a similar way as the 59 Minute Fundraiser. Parent volunteers will be in the neighborhoods passing out prizes as student groups reach specific goals: 5 sales=3 pcs of candy; 10 sales=cookie; 15 sales=soda; 20 sales=pizza. Each student in the top selling team of the day will receive a $\$ 5$ Chipotle gift card.
In our FMPA discussion we determined the ipad drawing will be open only to those who sell at least 10 items.
I also met with Ric \& Jenny last week. We discussed dates and possible pricing changes. We talked about some of the pros and cons of increasing the price to $\$ 15$ per item and eliminating the 3 for $\$ 36$ deal or changing it to 3 for \$40. Donna Roberson, our Savory Sweets rep, responded with positive feedback when I emailed her about the possible increase. We will need to make the decision tonight so that we can proceed with our contract with Savory Sweets.
