Private Lesson Plan - Maggie Laird

- Payment explanation has been given many ways, but is still confusing to folks.
- Feedback on ensemble time kids ARE allowed to do less than every single session.
- SignUp genius for volunteers is half way done.
- Need an email list of all FMPA members
- NEED MORE CHAPERONE VOLUNTEERS

Motion to have FMPA pay the cost of background checks for chaperones out of the after-school lesson program line item of our budget. Motion made by Sue, second by Den. Motion passed.

Savory Sweets Cookie Dough – Savory Sweets Fall Fundraiser: The cookie dough sale has begun! Parent reps went to the music classes last week to kick off the sale. Students were given a Savory Sweets brochure, order form, and a flyer with details specific to the FMPA sale. Extra brochures and order forms are in the Whitaker and Secondary Campus offices.

The Neighborhood Blitz scheduled for Sunday, October 9th, as it was originally planned was canceled. Students were still encouraged to form groups and go out and sell, but it was not an FMPA organized event. We did still plan a few incentives to motivate the students. We designated "mystery houses" throughout Finneytown where students were given prize vouchers. Students will turn those in this afternoon (Monday, October 10th) and be entered into a raffle for \$50.

A mid-sale email will go out to parents later this week reminding them of the order due date and explaining details of pick-up and delivery.

Class Reps will collect orders and money next Thursday and Friday (October 20th,21st). Details of that process will go out to them later this week too.

Saturday, October 22nd, starting at 10:00, I will double check orders and count money. Any board members that are available are requested to be at my house (7892 Pinemeadow Lane) to help! Coffee and breakfast snacks will be provided!

The plan is to use the PAC Stage this year – folks will still come into the lobby for pickup, we will get the order and run it out to them from the stage.

Business fundraiser initiative – \$1500 so far, Honerlaw & J. Gumbos adding. Promo is on MB trailer, in concert programs, eventually on electronic sign.

NEW BUSINESS

Question about senior banners: Heidi R. already paid for the large banners of senior marching band members. The money came out of marching band expense budget as directed by MK.

Early in our meeting tonight we discussed who can staff the lobby for this week's concert, for memberships and cookie dough. Sue will make an announcement during the program about FMPA.

Veronica and Andy Bishop came tonight to promote the Finneytown Holiday Market on Sat. Nov. 12 at Whitaker elementary. They would like us to join the Market with luminary information for sales. 10am-4 pm on 11/12, have 30 vendors, need customers.

Adjournment – motioned by Den, and Maggie seconded, that we adjourn the meeting. Motion passed. Meeting adjourned at 9 pm.
