## HS/MS Choirs - VP Sue Connell

FMPA really needs a middle school VP to be found, having had the position open last year and this year thus far. Discussion of asking Ms. Carroll to forward emails of MS choir parents to Sue so recruiting can begin in that way. Janet Cain has a middle school email "newsletter" she sends to any MS parents who are on her list - and she'd like to expand the list. She can put out the word for a MS choir rep in that email letter if we'd like.
Question if $6^{\text {th }}$ graders choir option is only the "X-period" after school choir or if they have a choir option during the day. We think it's just the after school option only, will need to double check with Ms. Carroll.

All-State question was asked to clarify how All-State families are assisted with entry fees. All-State members this year are: Zach Wuorinen, orchestra; Alexander Eberhardt, band; LaValle Coleman and Cooper Burton, choir. OMEA All-State convention with performances is Feb 8,9, 10, 2018 with different groups performing different times. Details pending as the conference gets closer. Heidi $R$ said she prefers to write checks of reimbursement for half of entry fees to the parent, but if a family wants upfront help with the fee she can write it directly to OMEA to go with a family's check as well. $\$ 275 /$ person, half is $\$ 137.50 /$ ea. 4 students $@ 137.50=\$ 550$, which is the exact amount we budgeted in our line item to help. (addendum: Sue B sent an email to Ms. Carroll on 9/16 to be forwarded to those families explaining the reimbursement process. - ed.)

## Elementary Music Staff - Heidi Johnson

FLSD is sending sincere thanks to the Cincinnati Arts Association for awarding Whitaker Elementary music teacher Heidi Johnson a transportation grant that will give Whitaker fourth graders the opportunity to see Black Violin at the Aronoff Center for the Performing Arts in October. For the fourth graders, seeing the performance is the culmination of the fourth-grade general music curriculum standard on learning audience etiquette. Each year, Ms. Johnson takes her students to a live performance after they have studied how to be a good audience member.

## School Board report - Scott Haarlammert

Re: bussing - with this as the first year of contracted bussing, if transportation issues are personally affecting your family, please escalate the issue so we can address it and put it to rest. Address with principal and call the transportation number listed.

Biggest focus now is long-range planning. There was a long-range planning committee 3 years ago but not well publicized then. Currently in visioning stage with community, staff, etc. Subset of longrange planning is facilities. The state can offer around 25 million dollars toward facilities (approx.. $46 \%$ of money toward classroom space needed). Need to formulate plans and we need to talk as a community about it all. When you get a survey, PLEASE TAKE THE SURVEY, especially encourage neighbors, etc. who are not very connected with the schools to complete their surveys. Scott is calling it the 50 year opportunity - schools have been here about 50 years, historically low interest rates.

Three open board seats (Scott, Cindy Rebman, Anita Ruffin) for 2018 - on the Nov. ballot are Cindy Rebman, Chad Engleman, and Steve Stuhlreyer. Scott plans other ways to stay involved with the schools and community.

## Communication Report - Deb Amend

I am finishing up the first edition of the FMPA Music Notes for this school year. I would like to get it out at the end of this week for distribution. Previously, I had forwarded this to Joanna and she forwarded it on to the members. I would like to continue this with Rebecca if that is not a problem with her. We also published the first 2 editions on our FB page as a kind of "teaser" for those who haven't joined.

However, the FB page has been very active, and I suspect that the newsletter will be most beneficial to members who do not use fb. I will keep the format for the newsletter simple and straightforward and continue to pull photos from the FB page.

Currently the FB page has 176 "likes". Our posts have reached 4061 people as of this week, and since September 5th, we have had 1300+ views of our videos. We may want to discuss how to leverage this viewership for promoting our fundraisers.

## Website report - Bill Fessler

Website updates were made.
Requested additional information from Chris Wolferst this morning and will get the rest of the cookie dough info up ASAP.
Also talked to Maggie briefly about adding a Private Lesson payment option to payschools, we can discuss details tonight. Technically, probably no problem -
Heidi Reeb - please think about this and we can discuss tonight... would this create any issues with the associated fees involved with Payschools? We can add a 'convenience fee' to cover it. We've not used that feature for other products. Discussion: the convenience fee we are charged is $4.25 \%$ so we should charge this over and above, for parents who might want to pay for private lessons through our PaySchools account. This way we are not subsidizing those who pay online.

- We are in conversation about an updated avenue for possible online payments. Many parents have stated in the past that online payments would be much easier.
- There are a couple students that never paid for lessons from the 16/17 school year and a few that have not paid for summer lessons for Sam Fronk. I would very much like to avoid this problem for $17 / 18$. Perhaps lesson fees have to be paid by the end of that month and if they don't get paid they cannot take lessons the next month. For example, if a student has four lessons in September at \$80, the $\$ 80$ will be due no later than September 30th. I welcome suggestions.

Discussion during meeting of how online payments might work for private lessons. Various tiers of payment make it more complicated, but general consensus is that it would be doable but need input from Mr. Kennedy. For now, payment is only by check to Laura Beverly. Bill will put payment info on the FMPA website (Maggie will email it to him) and Maggie will ask Laura's permission to put her contact information on our website.

## Treasurer's Report - Heidi Reeb

Heidi is using the accounting spreadsheet categories that MK has put together.
2 of our memberships were paid on clovergo.
59 minute fundraiser - about $1 / 2$ came through PayPal and $1 / 2$ by checks, just fyi.
Treasurer's report ending 9/11/17 was reviewed. Motion to accept the 9/11/17 report was made by Den, seconded by Maggie. Motion passed.

## OLD BUSINESS

59 minute fundraiser update: $\$ 12,922.27$ per treasurer's report. Need to find out from MK who is the top fundraiser, not who got most pledges but who has had the most actually come in. Some parents have asked. Also unsure when to close out the line item. (Ed. Note: MK later said he plans to keep it open til the end of September).
Den said, re: business advertising, "it's coming, that's all I can say for now".
Disney trip challenges/alternatives: Per Jenny T., who does not have all the information on this, there are just over 50 students verbally committed to the trip (100 needed) and the instrumentation mix is not a good mix for performance. (Ed. Note: later conversation with MK, 53 kids pre-deposit deadline. He planned to email to cancel the trip on Sept. 15).
