April B brought up the idea of charging an additional \$1 or \$2 more dollars for spirit wear instead for selling it at cost to raise more money. We currently use ProStitch. Eric Muchmore & Jasmine Smedley to get a quote for t-shirts from differently suppliers.

Quick discussion about reimbursement and income report forms and handling financial matters securely. Need to do an audit on a yearly basis.

Luminary Report

There were no luminary kits left from last year except 3 that were donated to the PEM committee for the concert on Dec 7. I had about 8 volunteers that put together 152 luminary kits in about 2 hours on Sat, Nov 23! We sold 109 luminaries. 28 were sold at the 2 concerts. 49 were ordered per Pay Schools. The rest were mail orders or people that contacted me per text. Deliveries were made on Wed, Dec 11 and Thurs, Dec 12, plus some last minute orders on Sat, Dec 14. We had a lot of expense this year because we had to buy all the candles, individual luminary bags, as well as brown bags for the kits. We

had plenty of sand and there is still a lot left. We should have 43 kits left for next year, 3 of which will be donated for the PEM concert.

We will need to look into if we do the luminary program again or not for Nov/Dec 2020.

New Business -

Ms. Johnson has retired from Whitaker. Mrs. Mel Wallace is the new music teacher and comes with many qualifications.

Spring Fundraiser - Don't really want to have to do anything; but we might have to do it if DBTS is not successful. The business fundraiser could be a piece of this, including in regards to the trailer.
