DR. CHAT

Hi all. This is Chrissy Berry here. Some of you know me as the old bartender from The Seashell or Legends or Chowder Pot. Some of you know me as Walter's wife. To others I'm the Deacon at church, one of your grandson's Scoutmasters, or a fellow firefighter with SFD (ok these days I just go for the feed!).

Let me introduce you to the professional me. I am an Occupational Therapist.

I work part-time with the Veteran's Administration. Through the VA I visit the homes of Veteran's who might need some equipment to make life at home a little easier and/or safer. With a quick call to your primary doctor at the VA (631.261.4400) just ask for a Home Safety Evaluation. Then the VA will send Russ L'hommedieu DPT (I'm sure many of you know him from physical therapy or the ice cream shop he used to have.) or me - to your home. We will observe how you move within your home and then make recommendations for equipment such as stair glides, ramps, grab bars, shower chairs, power wheelchairs, transport wheelchairs, life alerts, etc..... If we recommend it then the VA can provide it!

The VA also has a program called the Home Based Primary Care (HBPC) program. If getting to the Northport or Riverhead Clinic is too difficult for you our team comes to you. The HBPC team consists of a Medical Doctor, Nurse Practitioner, Registered Nurse, Registered Dietician, Psychologist, Social Worker, Pharmacist and PT/OT (once again handling equipment options). If you are interested in HBPC please call your primary doctor at the VA or the HBPC Office at 631.754.7903.



Polio vaccine, preparation of poliovirus given to prevent polio, an infectious disease of the nervous system. The first polio vaccine, known as inactivated poliovirus vaccine (IPV) or Salk vaccine, was developed in the early 1950s by American physician Jonas Salk. This vaccine contains killed virus and is given by injection. The large-scale use of IPV began in February 1954, when it was administered to American schoolchildren. In the following years, the incidence of polio in the United States fell from 18 cases per 100,000 people to fewer than 2 per 100,000. In the 1960s a second type of polio vaccine, known as oral poliovirus vaccine (OPV) or Sabin vaccine, named for its inventor American physician and microbiologist Albert Sabin, was developed. OPV contains live attenuated (weakened) virus and is given orally.

Vaccines, whether killed or live, may contain strains of all three poliovirus serotypes—PV1, PV2, and



PV3—or of just one or two (serotypes are closely related though distinguishable forms). For example, trivalent OPV (tOPV) contains live attenuated virus of all three serotypes and thus is effective against all three se-

rotypes of the virus. In contrast, monovalent OPV1 (mOPV1) contains live attenuated virus of only PV1 and thus is effective only against serotype 1. In general, for both IPV and OPV, three doses of vaccine are required, with a fourth ("booster") given when a child reaches school age. Because PV2 dropped out of circulation in the 1990s in countries where the disease was endemic, a bivalent oral vaccine, or bOPV, targeting PV1 and PV3 was developed. In the first decade of the 21st century, this vaccine was found to be more effective than either mOPV or tOPV in reducing the number of cases in polio-endemic countries.
