WHAT IS THE "RIGHT WAY" TO VIEW UNITED STATES HISTORY?

Should the History of the United States be viewed through the filter of oppressor or liberator? How one chooses to examine United States history says a lot about how one chooses to live in the United States today.

COVID - 19 VACCINE UPDATE FOR NORTHPORT VA MEDICAL CENTER PATIENTS

Northport VA Medical Center is offering the Moderna COVID-19 vaccine to enrolled **Veterans already receiving** care from VA, based on CDC and VA risk criteria. If you're eligible to get a vaccine, your VA health care team will contact you by phone, text message or Secure Message (through MyHealtheVet) to schedule an appointment.

We are contacting Veterans in all locations in an organized manner in accordance with the collaborative Risk Stratification criteria developed by the Centers for Disease Control and the Veterans Health Agency which incorporates both age and significant health concerns (comorbidities) and informing Veterans that Northport VA Medical Center (which includes all of our Community Based Outpatient Clinics) is scheduling vaccination appointments.

Our goal is to vaccinate all Veterans receiving care from us.

Veterans who are not enrolled in VA care, are encouraged to contact VAMC Eligibility Section (631-261-4400, Ext. 2567/2659) to request an application for enrollment.




