

General Terms and Conditions (AGB)

for Mediumistic Readings / Spiritual Sessions

1. Description of Services

The session is intended to establish contact with deceased individuals (family members, friends, or acquaintances) in the spirit world.

It is an **evidential mediumship session** in which information is provided that serves as evidence of the identity of the person communicating from the spirit world.

2. Purpose and Content of the Session

The main purpose is to demonstrate the **continuity of life after physical death**.

Evidence will be presented to you, and you will be asked to confirm the information with “yes,” “no,” or “I don’t understand.”

No predictions about the future or decisions will be made. You remain **fully responsible** for your own life and the decisions you make.

3. No Promises of Healing or Professional Advice

No diagnoses are given, no therapies performed, and no promises of healing are made.

This session does **not replace** medical, psychological, legal, or financial advice.

Any decisions or actions taken as a result of the session are the **sole responsibility of the client**.

4. Confidentiality and Data Protection

All sessions are **recorded**, unless otherwise agreed.

The recording is **strictly for personal use** by the client.

Without **explicit written permission**, recordings or content may not be shared with third parties, published, or made publicly accessible.

All personal data is handled confidentially in accordance with applicable data protection laws.

5. Payment

The fee for a session is **£55.00** for a duration of **30–40 minutes**.

Payment must be made **in advance via PayPal**, no later than before the session begins.

A booking is **only confirmed** once payment has been received.

6. Refunds and Session Cancellation

If the client feels within the **first 10 minutes** that the session is not appropriate or resonating, this **must be communicated immediately**.

In such cases, either a **full refund** or a **rescheduling** of the session will be offered.

After the first 10 minutes, the session is considered **accepted**, and **no refund will be issued** thereafter.

7. Cancellations / No-Shows

Cancellations or rescheduling are free of charge up to **36 hours before the appointment**. In case of **late cancellations** (less than 36 hours in advance) or **no-shows**, **no refund** will be given.
