- 1. Current Bank Balance is \$24,092.30

- 4. Lacey will establish a VENMO Account for the HOA. This will allow members to pay their HOA fees electronically.
- 5. The Fall seasonal decorations at the entrance signs were purchased and placed by homeowner Nancy Brink. Lacey has reimbursed Nancy \$89.97.

Committee Reports

Architectural Review Committee –

- Decorative Street Signs and Mailboxes
 - Dan indicated that Bob Bouril, (Chair of the Architectural Review Committee - ARC) and the ARC selected new mailboxes and posts for each lot. The cost per lot is approximately \$200 plus an estimated \$150 for installation. This will be paid by the HOA. It is anticipated that this project will commence in October 2024 and be completed in 2025.
 - 2. Bob Bouril will contact the Town of Middleton regarding replacement and placement of the green reflective street signs.
 - 3. The three Sauk Point Estates Signs at the entrances to the development will be refurbished.

Landscape Committee –

- Lot 57 Mowing The owner of Lot 57 contacted the Board and indicated that tall grass was growing behind his property. The property abutting Lot 57 is not Sauk Point Estates property. However, Dan Rosati said the owner of Lot 57 indicated that the grass has now been mowed.
- Messner Landscaping's contract runs through November. Kathy has contacted Messner and requested quotes for a new contract, since the existing 3-year contract with Messner's ends this year.
