• Landscape Committee -

- Tree Planting Update The Hawthorne trees that were planted in May along Summerfield Drive and the park area off Swoboda and Magellan are doing well in spite of the drought, thanks to the many efforts of neighborhood volunteers that continue to diligently water the trees that were planted in Outlots this year and last year. Kathy Speck provided a cash tip of \$40.00 to two staff from Messner's Landscape that helped her water several of the new trees when they were here for the field mowing. Lacey Smith will issue a check to Kathy to reimburse her for the cash payment.
- Outlots The Landscape Committee would like to plant trees in other Outlots in the neighborhood. However, there are various Town of Middleton restrictions regarding planting in some of the Outlots because of drainage issues. Kathy will work with landscaper Scott Harrington and the Town of Middleton to explore options.
- Lot 57 Mowing The owner of Lot 57 contacted the Board and indicated that tall grass was growing behind his property. The property abutting Lot 57 is not Sauk Point Estates property. Therefore, Dan Rosati said he will call Lot 57's owner and suggest he contact the Town of Middleton to determine whose responsibility it is to maintain that property.
- Messner Landscaping's contract runs through November. Need to contact Messner and request quotes for a new contract, since the existing 3-year contract with Messner's ends this year. Dan indicated he will work up a Request for Proposal (RFP) and Kathy Speck will submit it to various landscaping companies for competitive quotes. Kathy asked for suggestions for landscape companies to contact.

- **HOA Insurance Coverage** Coverage renews in October. Dan will oversee the renewal process with West Bend Insurance Company.
- Mailboxes, Posts and Sign Replacement Dan will ask Bob Bouril, Chair of the ARC, to elicit quotes from contractors for this project.
- Other Business It was brought to our attention that some members may not be aware of the Sauk Point HOA Covenants and Restrictions. Therefore, Dan Rosati will provide all members with a copy of this document.
