## Membership in the Church

(A SUMMARY OF THE CANONS)

The National Canons address membership in the Church and the expectations the Church places on those members:

1. Members of the Church are those persons who have been baptized in the Name of the Father, Son, and Holy Spirit with water, and whose baptism has been duly recorded in this Church. Adult members are those persons sixteen years of age and older.
2. All adult members of the Church are expected to be confirmed in the Church, or if they have been confirmed in another Christian Church by a Bishop in Apostolic Succession, to have been received into this Church.
3. All members are considered to be communicants of this Church who have received Holy Communion at least three times during the previous year in this Church.
4. All persons in this Church are expected to celebrate and keep the Lord's Day and participate in the Church's public worship.

Communicants in good standing are those who have:

- A. Attended corporate worship on a regular basis in their Church unless they have been prevented from doing so for good cause;
- B. Have been faithful in the giving of their time, talents, and treasure for the spread of the Kingdom of God.

## Minutes - 2020 Meeting Minutes

Father Luckritz Called the Meeting to order at 10:50 am 2/9/2020

It is wonderful to have an interested, supportive and dynamic neighbor like Michael.

A motion was made, seconded and passed accepting the Agenda as presented.

A motion was made, seconded and passed accepting the 2018 Annual Meeting minutes.

Father reviewed the Nominating Committee's report and thanked Tom Herget and Cathie Patterson for their service. See page 6 of the Annual Report for the new Vestry. Tom will continue as Treasurer, but not as a voting member of the Vestry.

Named the delegates and alternates to the 2020 Convention: Greg Gyllsdorff, Linda Barber, and Cathie Patterson with Gale Blogg and Pat Wilson as alternates.

A motion was made, seconded and passed accepting the Vestry and Delegate slate.

Rector's Report. Father referred to his written report on page 7. He noted that we had come significant losses during the year and especially remembered Gloria Maudsley, Peter Barber and Ken Palmquist. He also mentioned making renewed contact with three families: Joanne Maynard and Karen Zimmerman. Attendance averaged 49 for the year, but will be difficult to maintain in the coming year. A motion was made, seconded and passed accepting the Rector's verbal and written report.

Sr. Warden Report: Marilou Clohessy referred members to her written report. Father thanked Marilou for her exemplary service.

Jr. Warden's Report: Ken Adam referred to his building and grounds report in the Annual Report and stressed what a wonderful year of progress we have made! Father thanked Ken and Rob.

A motion was made, seconded and passed accepting the Warden reports.

The winners of the fence auction were announced. Guy Stephens won one section; Cathie Patterson won the other two!

Father praised the work that Maria Ulloa and Gary Gorney, keep our grounds beautifully maintained during the year.

Music: Greg Gyllsdorff thanked everyone who made our music program great last year. He also stated that there is an opening on the Bell Choir and asked for volunteers.

Sandwich Board: Gale Blogg reported that the Sandwich Board continues to do great work and that Trinity has expanded the number of times it hosts it. More support from the Congregation is needed.

St. Margaret's Guild: They had a wonderful Christmas Party with Betty Giles at Bickford on Galena. They are looking to add some evening events to allow more women to attend. They had a successful Quilt fund-raiser and many bake sales during the year.

The Altar Guild. Father praised Pat Wilson for all her efforts behind the scenes and for the other members of the Guild.

A motion was made, seconded and passed accepting the committee reports

Final Comments: Father said that there was always someone who should have been thanked but was overlooked and apologized. He said it was a terrific year at Trinity and good things are ahead.

There was extra food. Members were asked to take some home.

Doug Tierney commented on how welcome he has felt since he began coming here and thanks us for being so inclusive.

## Rector's Report

Dear Friends,

Last year at our annual meeting, little did we know that 2020 would bring unprecedented challenges to Trinity Episcopal Church, every single member, their loved ones and families, the nation, and the world. We found ourselves traveling on unknown paths. A pandemic, economic uncertainty, and social unrest provoking a renewed movement for justice, brought us three challenging, revealing, transformational, and defining times. How we respond as a Christian community reveals our core and character and will shape us for generations to come. Appropriately, this year's Annual Report reflects in the pages that follow, how we shared those defining moments.

Your leaders, who are guiding our efforts, attempted at every opportunity to stay the course and to strengthen Trinity's presence and ministry. As you will see, this year's journey has not been filled with distractions from our strategic goals, but instead has served to sharpen our focus, our call to be God's presence in our community. We recognize that ours is not the first generation to face such difficult moments. During this past year, at least one article in our newsletter reminded us of those who served in the military during times of war.

During these stressful and turbulent days, we have found new ways to worship together and to build and strengthen community; the Sandwich Board moved to a new way of being independent and successfully established new ways of reaching the hungry and needy; those looking over our financial matters made sound decisions and successfully maintained those resources; those who oversaw the building and grounds were able to improve them and began preparing for our return to the facilities. Together we found ways to stay in touch online via Zoom and Facebook, as well as gentle reminders through a flowering plant or note expressing our concern for one another.

It was indeed a year of challenges, but they were met by a profoundly strong community of faith. I'd say we are a "feisty" and healthy parish. Feisty, I believe is an apt description for a parish that perseveres and so faithfully witnesses its faith and purpose for being. As I walk down the center aisle of the nave these days and pass by those pews, I see our members praying once again, just as so many have before them. I hear the voices responding and music echoing from the recently repaired and freshly painted ceiling. When it is safe, we will return. And while this year has been so different from previous years, one thing remains the same: Like members before them who have faced defining moments, the people of Trinity continue to pursue and live into the call to be God's presence in the world and to be faithful to that call, finding paths, moving forward with intention, witnessing God's love. I'm inspired by you, and I think often of the foresight of those long-ago members who understood the "feisty," purposeful call to plant, build, and become Trinity Episcopal Church, Aurora.



## Outreach Report

Trinity is amazing! Even when we could not be together in church, we came together to help others. Although we did not have our usual drive to help the folks at AID (The Association for Individual Development), we still sent money in honor of those who died of Covid-19. School supplies could not be collected but money poured in. To our surprise, Beaupre School said that, due to a large grant and remote learning, they did not need supplies. So that money was put toward our Christmas gift program. We sent out 15 Christmas bags, 12 to Beaupre and three to members of our congregation. Each bag had a gift card to Aldi's for food, and a Walmart gift card for each child in the family. Cathie Patterson filled the gift bags with candy treats and Christmas Cheer. **15 families and 37 children's holidays were made happier!**

Yes, Trinity is truly amazing. Thank you, thank you, thank you! AND money continues to come in afterward and so we have a nice reserve for helping others during the upcoming year. **Your Outreach Committee - Marilou Clohessy, Chair**

## Communication Committee Report

The Communication Committee was instrumental in keeping open and ongoing contact with Trinity's congregation. Individual contacts were made in distributing two deliveries of flowers and distribution of either Christmas flowers or Christmas decorations and sending out American and Episcopal Flags. We also increased the frequency of our semi-monthly Newsletters to monthly. We also completely redesigned Trinity's web page; [www.trinityaurora.org](http://www.trinityaurora.org). We instituted on-line giving and provided helpful suggestions to Father and Greg as they developed our on-line service presence. Weekly bulletins were sent out to those who couldn't access them electronically as were Newsletters to non-internet using Congregants. Our Service Register Books were digitalized, identifying a gap in documentation of Marriages in the 1940s. Books digitalized are Baptisms, Confirmations, Marriages and Funerals. They still need a proof reading and correction. Thanks to all who contributed. Newsletters from 1972 to current were also digitalized. The file of digitalized historic pictures of Trinity was reviewed and contents of each labeled - Thank you for both, Tom! **Respectfully submitted, Rob Borchert, Chair**

## Community Service Report

Trinity had one community service worker prior to the pandemic shut down. The Kane County Court Service commuted all Community Service hours so none were available. Trinity was re-activated as a site in September but we have not received any referrals since then.

## The Sandwich Board, LTD

Well, we survived 2020. It is great to say that we have not missed a single Thursday in our 33 years. We have survived the pandemic, snow storms, power outages, and flooding. I am reminded of one Thursday when there were only 100 sandwiches and somehow we served 125+ people. This was the story of the loaves and fishes. Amazing!

In 2020 The Sandwich Board became a 501 ©(3) non-profit organization. Thanks to the newly formed board of directors. This will enable The Sandwich Board to seek grants and be independent from the church as some grants are not for religious organizations. In March we started with sandwiches and people came to the door as we were not serving inside. The first months of quarantine, I was afraid to come out. So... Rob picked up the slack and then, Scott, Gale, Marsha, Jean, Maggie and Antonia. They are here every Thursday, handing out the lunches. What a blessing is this group!

We served on Christmas Eve and New Years Eve. The people are ever so grateful. People have donated clothing, hats, gloves, scarves, mittens, blankets. If you are cleaning out closets, remember we can really use outer ware and blankets. Our numbers are starting to average over 120 lunches each week. We served 3531 meals in 2020

## Property Report

- Major Building and Grounds activities.

Our grounds continued to be beautified by Maria Ulloa with help from our Sexton, Gary Gorney.

Gary also continued to touch up our external paint over the summer. This seems to be an ongoing project.

A new railing was installed by the Parish Hall entrance.

The Church ceiling and walls were painted

The berms in the parking lot were replaced. Parking stops were installed. Gary erected the advertising pole in the new berm.

Several leaking boiler pipes were replaced. The worst one was under the rear of the Church which had already been patched four times.

The boiler was upgraded to include a holding tank that should have been part of the original installation.

The Church was stripped of all Hymnals, Prayer Books, Bibles, cushions and everything else in preparation for Covid Cleaning.

The peeling floor under the pews was painted.

Tile was removed from the Chapel and at the bottom of the stairs by the bathroom.

The drain by the Chapel door was cleaned out and our flooding problem disappeared.

All remaining tile floors were stripped and waxed.

The hole the squirrel got in through was patched. The squirrel was captured and released in the wilderness

Gary continued to do touch up painting on the exterior of the Church



## Other Accomplishments

Preparation of Annual Report for the February 8, 2020 Annual Meeting.

The Jubilee Center received two grants; one from our Diocese and one from the National Church.

We had our Mardi Gras dinner followed by trivia by Tom Herget.

Trinity established and maintained an on-line presence for its services and actually increased attendance.

Due to the legacy of Betty Giles a new Trinity red Vestment was purchased.

Greg transformed the area in front of the Altar into our recording studio.

Trinity established an on-line giving process that has proved popular during this distancing time.

We applied for and received a Payroll Protection Program Grant that eased our reliance on the Memorial Fund to \$33,000.

The blessing of the animals occurred as a drive through event.

The Bell choir performed twice.
