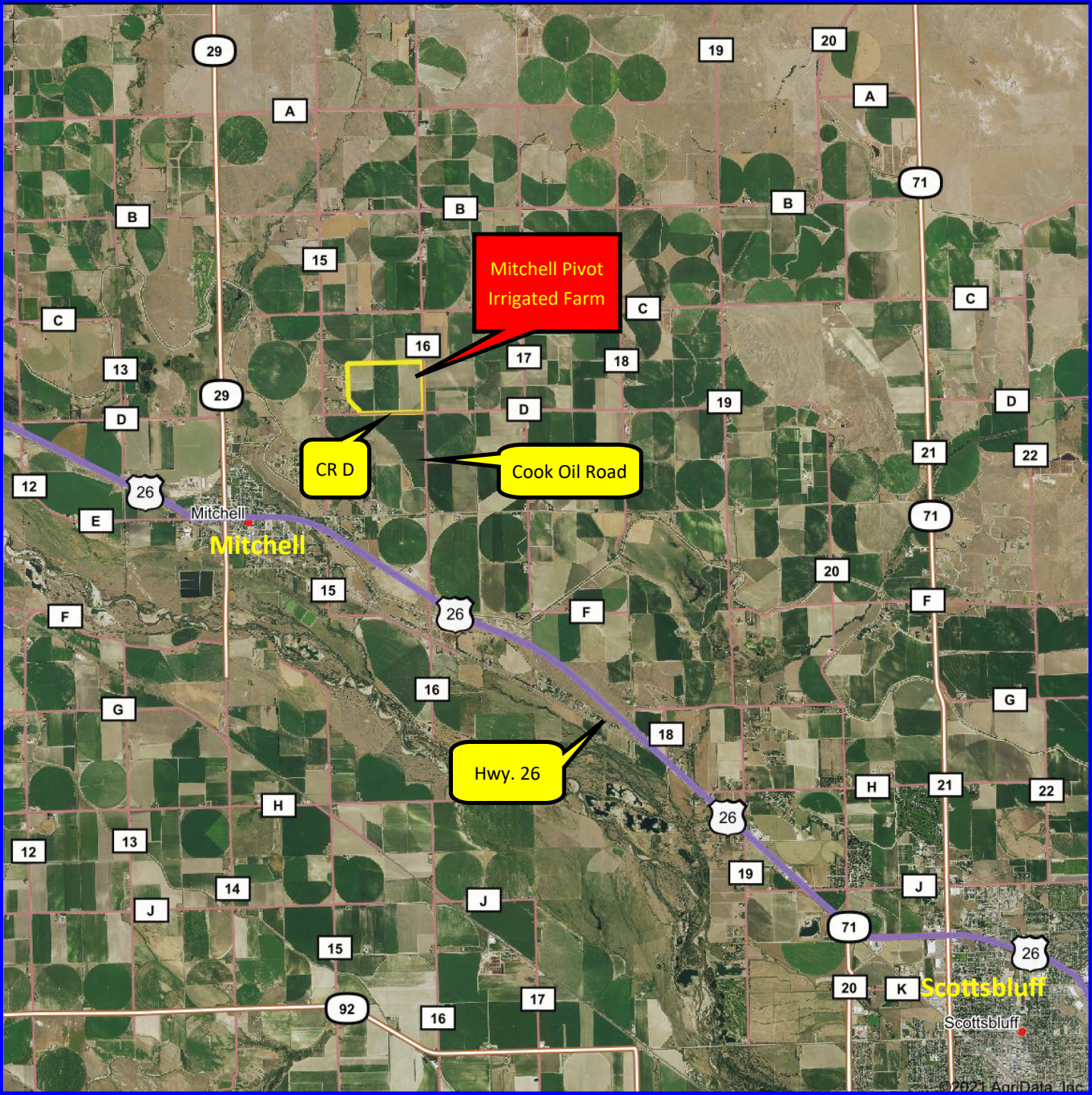

Mitchell Pivot Irrigated Farm



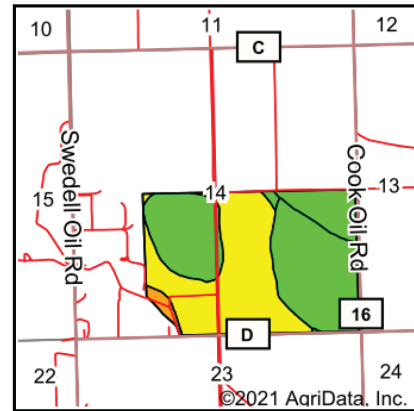
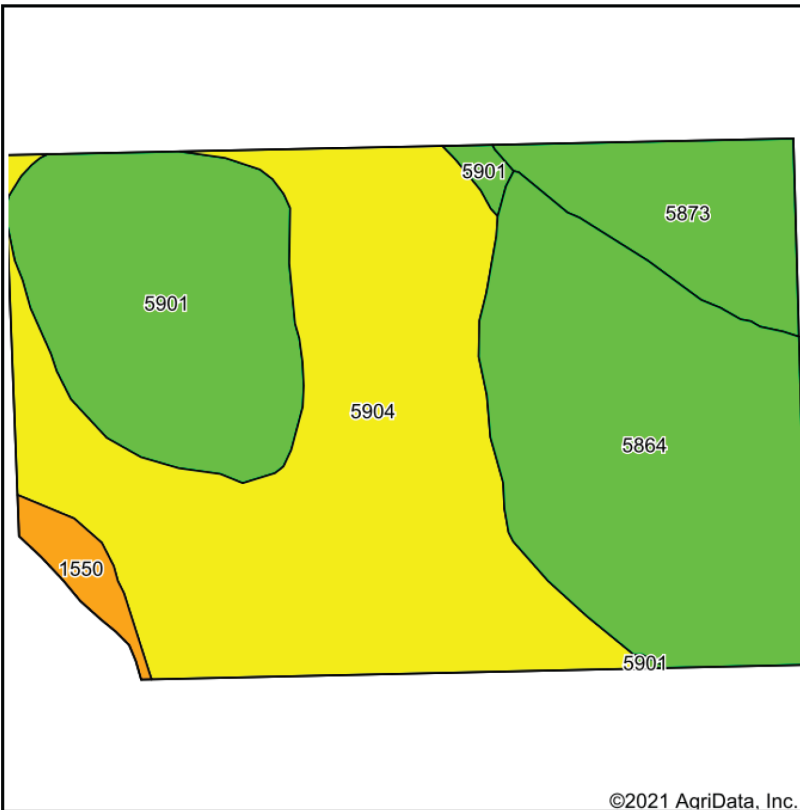

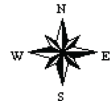
Soil Map
