### Motion on 2-Year Mandate

3. Whereas, the motion put forward by our outgoing Chair *Letitia Taylor* at the first call to order; on a two-year mandate for committee members lacks sufficient structure and foundation; and

Whereas, it is understood that an alternating 2-year mandate would provide a more effective and balanced approach to committee membership;

Be it resolved that:

The previous motion proposing a two-year mandate for committee members be revised and replaced with the following:

- Committee members shall serve an alternating two-year term, with half of the members' terms ending each year. Appointed staff members are not affected by this internal policy.
- A record of member terms will be kept in the Google Shared Drive and updated before June by the Chair, Vice-Chair and or Secretary to ensure accuracy.
- An official memo will be sent to the Chair of Parent Committee and the Secretary General (*Edu Act. 190*) each year as to the number of members and alternates required.
- Members may be reappointed for repeat consecutive terms, but only after they have been selected by Parent Committee as per Edu Act 185 and 185.1.
- A member may withdraw from the committee and is not bound to these terms. Should a member exit, the alternate will take their place and the remainder of their noted term.

The revised motion shall be implemented immediately upon approval. The Chair shall ensure that all committees and members are informed of this motion and its implementation and furthermore be entered into the handbook as such.

WHEREAS, the two-year mandate member list of the committee is in need of updating, due to vacancy and the forementioned motion that carried; and

WHEREAS, it is necessary to update the member list by individual vote of preference before year end;

Be it resolved that:

- 1. The committee shall update the two-year mandate member list by individual vote.
- 2. The Chair shall present the current member list to the committee.
- 3. The Chair shall then read out each member's name and ask the named committee member to vote, by filling one of the vacancies of the two-year mandate.
- 4. Committee members may vote either "yes" to be placed on the two-year list or "no" to remain on the one-year list.
- 5. The Chair will record each member's vote.
- 6. Taking into consideration the number of vacancies remaining in the two-year term section; should there be more members than required, names could be chosen by way of name randomizer if the committee so chooses.
- 7. The updated member list shall hereby be approved by the committee upon completion of the vote. The Chair shall ensure that all parties concerned are informed of the updated member list.
- 8. The list shall then be entered into the Google Shared Drive.

## Motion: Creation of a Disability Inclusion Working Group in the Western Quebec School Board.

Whereas, the number of students with special needs is increasing in the Western Quebec School Board (WQSB) and it is important to ensure that all students have equal access to education;

Whereas, the Special Education Advisory Committee (SEAC) hereby advises the creation of a Disability Inclusion Working Group, to identify barriers and promising practices for disability inclusion in the WQSB;

Whereas, the Disability Inclusion Working Group would include representation from the WQSB Council of Commissioners, WQSB staff members, SEAC, parents, and community experts;

Whereas, the Disability Inclusion Working Group would review policies, procedures, and practices related to accessibility, accommodations, and staff training, and consult with experts in inclusive education, school administrators, resource staff and educators, as well as parents of children with Individual Education Plans (IEPs);

Whereas, the Disability Inclusion Working Group would prepare a report on their work that identifies barriers to and promising practices for disability inclusion in the WQSB and provides recommendations to the Council for consideration;

## Proposed Motion To Council;

Therefore, be it resolved that the Council of Commissioners create a Disability Inclusion Working Group in the Western Quebec School Board with the above-mentioned objectives.

Be it further resolved that the Disability Inclusion Working Group report to the Council of Commissioners, on a regular basis and that their findings and recommendations be considered in the development of policies and practices related to disability inclusion in the WQSB.

Be it further resolved that the Disability Inclusion Working Group be given the resources necessary to fulfill its mandate and that the Council of Commissioners ensure that the Disability Inclusion Working Group is supported and valued.

This motion shall come into effect at the start of the new 2023/2024 school year.
