

PRESIDENT'S MESSAGE

2020 Tuscawilla Updates

As discussed in recent issues of *Tuscawilla Today*, your Board of Directors has voted unanimously to postpone large signature events that the Tuscawilla Home Owner's Association and the City of Winter Springs have historically scheduled throughout the year. Most recently our cities "Celebration of Freedom" event was postponed. In March, the THOA's signature "Family Fun Day" was postponed with the hope we could reschedule this annual event for the fall. Although our community appears to be working toward a relaxation of some "social distancing" recommendations, the number of positive infections in our area appears to make clear that an event hosting 1,000+ of our residents would not only be questionable from a public safety standpoint but would not likely be supported by local government entities such as the Seminole County Sheriff's office, Fire Department and the City of Winter Springs. Due to an anticipated low turnout for a rescheduled "Family Fun Day" it currently appears that this signature event will be canceled for 2020 in an effort to be both fiscally and socially responsible. Your Board of Directors continues to discuss a smaller social event such as "Tuscawilla's Wine Night" held last October with much success if it can be held in a socially responsible manner.

Upcoming Local Elections

The Tuscawilla community has long been recognized as one of the strongest voting blocks in Central Florida. We vote consistently in all elections at a record setting percentage. This track record of voting brings our community a great deal of clout with City, County and State officials. I would like to encourage your participation in all elections after carefully researching all available candidates. It is important to note that the Tuscawilla Home Owner's Association and its Board of Directors remains non-partisan and does not endorse particular candidates. We do however take a position on specific issues such as preserving green space, parks or detrimental projects that may affect our schools or property values.

The next scheduled election is the Primary Election on August 18th, 2020. Early voting is held from Saturday, August 8th through Saturday, August 15th. The General Election is scheduled for Tuesday November 3rd, 2020. Under Florida law, all registered voters are permitted to vote by mail. Requests for vote by mail ballots must be received in your local Supervisor of Elections office no later than 5:00 pm on the 10th day before an election. Your marked ballot must be mailed or delivered in person, reaching the Supervisor of Elections office no later than 7:00 pm on the day of the election.

Meet The Candidates Night

For many years, prior to each city election, the Tuscawilla Home Owner's Association has organized a well attended "Meet the Candidates Night". During the last election, the event was held at the Tuscawilla Country Club



and was open to all City residents free of charge. The evening is by far the largest attended local event of its type in the city but will once again be impacted by the health concerns of our residents during the national Covid crisis. Please mark your calendars for October 1st, 2020. Details will be forthcoming but it is the intention of your Board of Directors to hold a large scale ZOOM meeting whereby all city residents will be welcome to listen and view local candidates online while they discuss their individual vision for our community and provide details as to why they should be entrusted to lead our city.

ELECTION DATES



MEET IRIS VAGNINI

What do you do when your life is turned upside down? When you realize that everything you once took for granted is now priceless? How do I tell my boys? How are my elderly parents going to react? All these thoughts were spiraling through my head after being diagnosed with an ultra-rare disease that had an associated life expectancy of three years.

What started as a mere blurriness in my vision – and thought to be something as treatable as a cataract – ended up being Erdheim-Chester Disease, or ECD. This is a rare cancer characterized by an overproduction of specific cells called histiocytes whose normal function is to fight infections. The cells infiltrate tissues, making them dense and causing havoc on whatever organ they choose to attack. In my case, it has affected my skull, long bones, and the orbits of my eyes. When my disease was first diagnosed in March 2012, there were approximately 300 reported cases worldwide, but today, with the awareness brought by the Erdheim-Chester Disease Global Alliance (ECDGA), there are as many as 1,000 patients globally. Because of this great organization and dedicated doctors and researchers, treatments have been discovered that stabilize the disease. Because my orbits are affected, my main struggle has been trying to save my vision. Many harsh drugs and chemotherapy treatments later, my immunity continues to be compromised, and presently I am being treated with an oral targeted chemo drug that has kept the disease at bay.

Because wishing the disease away was not working, I needed to find something to help me cope with this new reality that I faced. I needed to keep my mind occupied, so I started taking walks and exploring the extensive garden we created in my backyard years earlier. I'd spend hours on the swing pondering the uncertainties in my life, but at the same time, I was thankful for so many things. I soon found myself refocusing on the environment instead of on my health issues. My attention was now directed at the beauty that surrounded me – the beauty that I had somehow missed while engulfed in daily tasks. I began to feel a sense of peace as I sat and listened to sounds I had never noticed before – sounds of different birds chirping and singing. These sounds led me under bushy trees and around overgrown bamboo. We had a small Canon camera at the time, and I began to bring it outside with me to capture my newly discovered birds. I never really had an interest in photography, but I was determined to catch these colorful creatures to later share with my husband.

At first glance, my photos seemed ordinary and nothing special, but I was soon being complimented by my family and friends on Facebook for what they called beautiful pictures. My biggest compliment came from George Carey, a Key West artist who saw a picture of my arbor covered with bleeding heart flowers and expressed that he "felt a painting coming." Ironically, he said that I had a good eye

for photography! I had never taken a photography course and was not much interested in reading the manual explained all the camera settings. My secret was to focus and shoot. The lens magically captured the images, and I always seemed to be at the right place at the right time. I call



those special moments "God moments." He managed to place the most beautiful birds before me when I most needed them. Much of the time, I ended up capturing rare poses I didn't even see until I uploaded the pictures! I call those moments ... luck! There was no special skill involved, just a sense of determination and true joy in capturing a special God moment – a moment that would never be relived but would remain alive in an image.

During this time, my husband, Tom, installed several bird feeders with a variety of fruits and seeds, along with birdbaths which further attracted many species of local and migrating birds. Among the most common visitors are Northern Cardinals, Summer Tanagers, Brown Thrashers, Carolina Chickadees, and a variety of warblers and woodpeckers to name a few. Every year, between 25 and 50 American Goldfinches arrive in our yard, devouring many pounds of seeds a week and putting a dent in our wallets.

By 2014, I had snapped so many nature pictures that I decided to compile my best ones into a calendar with inspirational captions, serving as a Christmas gift for family, friends, and my many doctors. The "Backyard Photos by Iris" calendar became so well-liked that it evolved into a yearly project and is now an expected tradition. For two consecutive years, I sold them to raise money for ECDGA, which helps fund new treatments, research, and patient support. Hating to throw the calendars away at the end of the year, some recipients have cut out and framed the pictures, displaying them in their homes or taking them to nursing facilities for patients to enjoy. An assistant at my doctor's office even uses the pictures as postcards.

What started out as a distraction from my anxieties has transformed into a gift – a passion I am able to share that brings joy and inspiration to others. I have heard from many friends who have been inspired to purchase bird feeders and birdbaths and are eager to know my secret on attracting these birds. Personally, it has brought me hope and tranquility, and here I still stand – eight years later – beating the odds with both chemotherapy and photo-therapy.



CROSS SEMINOLE TRAIL MISSING LINK UPDATE:



The City of Winter Springs Economic and Community Development Director, Christopher Schmidt, has reached out to the Seminole County Project Administrator of Cross Seminole Trail (Terry Simpson/Consultant) for the latest information. As of July 21, the Contractor has "broken ground" by starting to remove some of the existing sidewalk near the entrance to Layer Elementary School. Initial work will focus on trail construction on the east side of the school entrance and reconstruction of the east side of the school entrance itself. When that work is complete, the operation will shift to the west half of the school entrance to perform work there. The contractor's intent is to have the work at the school entrance complete by the time classes resume, which is currently slated for August 17th. Once the work is complete adjacent to the school, work will continue proceeding west along SR -419.

Project Description - Approximately 0.7 miles of new 14 foot wide asphalt and concrete bicycle/pedestrian trail along SR-419 beginning at the existing trail end on the south side of Spring Hammock Preserve going south, then east and ending at the entrance to Layer Elementary School. The project will also include new drainage, a railroad grade crossing and signalization at the entrance to Layer Elementary School. Construction officially began July 13 and is scheduled to last for about 5 months (~150 days).

- Check your credit.

- Protect your Social Security Number.
 Only provide it when you MUST.
 As an alternative, provide only the last four digits.
- Shred sensitive docs.
 Shred unwented credit card and

Shred unwanted credit card applications, cancelled checks, bank records, or any document containing personal information.

Secure financial data.

Before you disclose credit card or other financial account numbers on a website, make sure the site offers a secure or encrypted data transaction. Check for the icon of a lock in the browser window, and verify the URL changes from "http" to "https."

Use strong passwords.

A combination of 10 to 12 letters, numbers, and symbols.

Don't use something guessable to someone who has information about you. Don't use the same password for multiple accounts.

■ Ensure mail delivery.

Don't leave mail in your mailbox overnight. If you are travelling, notify the Post Office to have it held, or have a neighbor pick it up.

"Know phishing."



CROSS SEMINOLE TRAIL RULES

The following rules apply to all Seminole County Trails:

- Be courteous: all trail users, including bicyclists, joggers, walkers, wheelchairs, skateboarders, and skaters should be respectful of other users, regardless of their mode of travel, speed or level of skill.
- Keep right: always stay to the right as you use the trail.
- Pass on the left: pass other trail users going in your direction on their left. Look ahead and behind to make sure that your lane is clear before you pull out and around the other user. Pass with ample separation distance. Do not move back to the right until you have safely gained distance and speed away from the other user. Faster traffic should always yield to slower and on-coming traffic.
- Give audible signals when passing: all users should give a clear warning signal before passing. A voice, bell, or soft horn may produce this signal. Voice signals may include "passing on your left" or "skater to your left." Always be courteous when providing the audible signal.
- Be predictable: travel in a consistent and predictable manner. Always look behind you before changing positions on the trail, regardless of your mode of travel.
- Control your bicycle: inattention, for even a second, can cause disaster. Stay alert and maintain a safe and legal speed at all times. Youth helmet laws are in effect, as well as other "rules of the road" as indicated by State statute.
- Do not block the trail: when in a group, including your pets, use no more than half the trail, so as not to block the flow of other users. If approached by users from both directions, form a single line or stop and move to the far right edge of the trail to allow safe passage by these users.
- Yield when entering or crossing trails: yield to traffic already using the trail, when entering or crossing the trail at uncontrolled intersections.
- Do not use this trail while under the influence of alcohol or drugs: it is illegal to use this trail if you are under the

- influence of alcohol in excess of the statutory limits, or if you have consumed illegal drugs. Persons who use a prescribed medication should check with their doctor or pharmacist to ensure that it will not impair their ability to safely operate a bicycle or other wheeled vehicle.
- Clean up your litter: as a public facility, this trail shall be kept clean for the enjoyment of all users. Trash and recycling receptacles are provided at intervals along the trail. Pet owners are responsible for cleaning up after their pets. Littering on the trail is subject to a citation.
- Keep pets on leashes: all pets must be kept on secure and tethered leashes; pet owners are responsible for their animal's behavior and clean up.
- Motorized vehicles are prohibited and use of such vehicles on the trail is subject to a citation: excluded from this rule are electric wheelchairs, golf carts operated by trails staff, and public maintenance and safety vehicles.
- Equestrian trail use shall be based on the following:
 - ♦ Trailer parking and hitching posts shall be provided in designated areas of proposed County trailheads;
 - Equestrian owners are responsible for their animal's safe control at all times;
 - ♦ Equestrian users must remain on the provided unpaved equestrian or designated path;
 - ♦ Riders should pass other trail users with verbal warning and extreme caution;
 - ♦ Riders must dismount upon approach to multi-user bridge structures and walk the animal across.

- Make sure all gutters and downspouts are operational and free of debris.

- If floodwaters are present, turn off all electricity.
- If you must evacuate be sure all utilities are turned off.
- Talk to a plumber about installing a backflow valve to prevent sewage backup.
- Have trees on your property inspected/ trimmed?
- Secure lawn or pool furniture, potted plants and other potential flying objects.
- Take pictures or video of your home in the event it is damaged.


