to vote at any time. The deadline to register in order to participate in the General Election is October 5.



A Stroll thru Connie Nadrowski's Garden:

What Grows Best Here and There? August 1979/2020... Dyson Drive: My husband, Larry and myself along with our two children Jason 7, Danielle 4, and Drue Noelle to arrive later in 1982, moved into our new Tuscawilla home from Ann Arbor, Michigan. Two acres of sugar sand, lots of thorny greenbrier vines climbing up many palms plus a few oaks; this was our new landscape. A blank canvas one might say. (Zone 6 to Zone 9) Since move-in-day, I've planted all the plants I could get my hands on. Our yard has evolved... One plant at a time! I did not start out as an avid gardener. This love of gardening gradually evolved over the years. Now that I am not working full-time, more opportunities are available to devote to this hobby. Over the years, I've been extremely fortunate. Many, many plants have been given to me with Love from other gardeners. Frequently, I look around our property and remember warmly who or where the plant's origin. In fact, some of the plants have taken so well that to this day I'm still trying to eliminate them. My flower gardens could be considered "test" gardens. Some survived and I've killed my fair share. Gardening is a humbling adventure. A lot of experimenting has been done with various plants and I've learned many hard lessons.

Back in 2005, I joined the University of Florida Extension Seminole County Master Gardener Volunteer Program. The course consisted of roughly 70 hours (12 weeks) of horticultural training for our Central Florida Zone 9. I continue to attend UF led classes and conferences to increase my knowledge of horticulture and gather up to date information on gardening in Seminole County. Not only have I learned a tremendous amount of knowledge about plants and our environment, I have met some very good friends. As Master Gardeners we give back to our community thru Extension help desk, plant clinics, Garden Expo, Educational classes etc.etc.

Gardening is a never ending experience but extremely rewarding....Formal gardens, straight lines, square corners and manicured edges are not for me. My ideal garden design should be an extension of my personality. From Hodgepodge gardening, progress is being made defining my goals. An overall plan is being contemplated to pull various planting areas together and naming different destinations within the garden and a name for the overall property.

My Goals: (Not a Simple Flower Garden)

- * Attract pollinators; bees, butterflies and humming birds
- * Attract migratory birds (even though they peck holes in my tomatoes and peppers)
- * Plant more native blooming and colorful foliage perennials
- * Make a place for wildflowers
- Diversity of plants to ensure full blooms for every season
- * Raised bed vegetable garden
- * Winding foot pathways, stepping stones andtrails leading to different experiences
- * Inviting shaded "Rest Stops"..... to sit for a while and *ENJOY*

MY VISION FOR WINTER SPRINGS AS YOUR COMMISSIONER





On Wednesday, September 16th, the City conducted a Ribbon Cutting ceremony to officially dedicate the newly constructed Pam Carroll Overlook at Trotwood Park. This impressive structure is an extension of the pavilion that creates a stunning vantage point for viewing the adjacent pond, fountain, and the other park features further to the west. Even though this is an addition to the existing structure, the professional engineering and construction is harmonious with the original architecture.

There exists a strong culture of "Collaboration" and "Creativity" among the staff members in the various departments in our City. Meet the "TEAM" responsible for the Mt. Trotwood features: Len Hartman, Mike Barclay, Brian Dunigan (Parks and Recreation), Clifton Mullis, and Luis Hernandez (Public Works). These gentlemen along with Kevin Maddox (Landscape Manager) meet once per week for a "brainstorming" session to develop design and construction solutions for various projects throughout the City. The melding of their individual skills has culminated in the various themes and theme-related structures found at our City Parks. This comradery has translated to completing most of our park projects utilizing our own staff members. This typically results in a savings of 50% - 60% for each of the projects.




Lt. Craig Lawson – Seminole County Fire Department July 2020 Employee of the Month



Important Rules and Options:

- To vote absentee, request a ballot using your supervisor of elections website, visit the office, write or phone. Deadline is October 24th.
- A photo ID is required to vote. A driver's license or passport is acceptable.
- Polling sites will have hand sanitizer, physical barriers and mask requirements.
- Election Day is November 3rd. Polls are open from 7 a.m. to 7 p.m.

Voter's Bill of Rights

- Each registered voter in this state has the right to (Section 101.031(2), Florida Statutes):
- Vote and have his or her vote accurately counted.
- Cast a vote if he or she is in line at the official closing of the polls in that county.
- Ask for and receive assistance in voting.
- Receive up to two replacement ballots if he or she makes a mistake prior to the ballot being cast.
- An explanation if his or her registration or identity is in question.
- If his or her registration or identity is in question, cast a provisional ballot.
- Written instructions to use when voting, and upon request, oral instructions in voting from elections officers.
- Vote free from coercion or intimidation by elections officers or any other person.

• Vote on a voting system that is in working condition and that will allow votes to be accurately cast.

Voter Responsibilities

- Each registered voter in this state should (Section 101.031(2), Florida Statutes):
- Familiarize him or herself with the candidates and issues.
- Maintain with the office of the Supervisor of Elections a current address.
- Know the location of his or her polling place and its hours of operation.
- Bring proper identification to the polling station.
- Familiarize himself or herself with the operation of the voting equipment in his or her precinct.
- Treat precinct workers with courtesy.
- Respect the privacy of other voters.
- Report any problems or violations of election laws to the supervisor of elections.
- Ask questions, if needed.
- Make sure that his or her completed ballot is correct before leaving the polling station.


