THE TUSCAWILLA LIGHTING & BEAUTIFICATION DISTRICT (TLBD)

The Tusawilla Lighting & Beautification District Advisory Committee is made up of Tusawilla residents and serves to advise city staff, the Mayor & Commission. Their responsibilities include the oversight of maintenance to the medians on Winter Springs Boulevard and the entrances to our community including our grand fountains. Funds are raised through special city property taxes paid by Tusawilla homeowners. During the October 21st meeting, the board discussed traditional budget issues as well as the replacement of aging Laurel oak trees along Winter Springs Boulevard. Many other topics of concern were discussed as the details of maintaining our community sometimes appears endless.

All TLBD meetings take place at City Hall. Tusawilla residents are welcome to attend these meetings and provide input to support the efforts of the committee as they address maintenance issues and upgrades to the common areas within our community. Having served on this board in the past, I can assure you that the city staff and board members would enjoy hearing any constructive ideas from residents. The TLBD committee meets on a quarterly basis and is open to the public.

TUSCAWILLA PRIDE AND RESPONSIBILITY

Each month, I receive several emails from residents who have strived to maintain their own property in excellent condition but had become frustrated with the condition of a neighbor's property. I understand their concerns. When a home owner neglects his/her property, they impact all of

the homes on the street. Usually, simple lawn maintenance and keeping the trees and hedges trimmed can make a significant improvement. Although code enforcement is not the role of your Tusawilla Home Owners Association, we would like to encourage all residents to do their part in keeping Tusawilla a beautiful place to live.

THE MONTH OF NOVEMBER

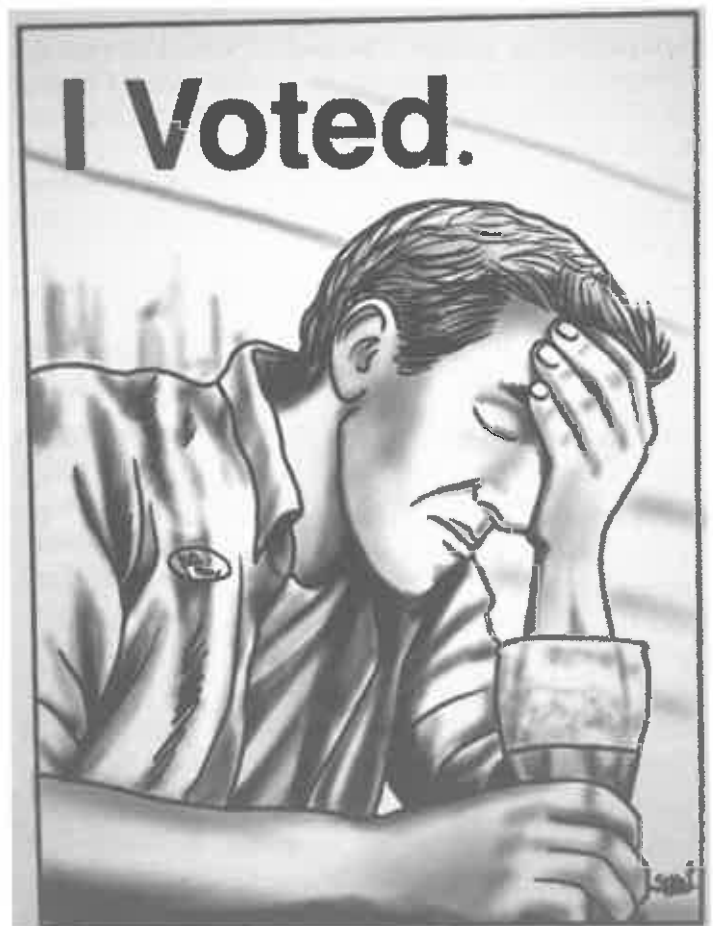

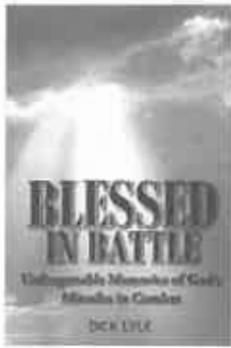

On Tuesday, October 13, the City had a formal "Ribbon Cutting" to dedicate the refurbished entrance roundabout at Trotwood Park. This project has been under construction for the past several weeks. The Construction "TEAM" kept their work under a tarp for much of that time and the unveiling of the feature was a surprise to most of our residents.

This is the latest improvement to arrive at our local Trotwood Park thanks to the combined efforts and skills represented by our city staff. Once again, they have managed to combine concrete, stone work, and landscaping into an amazing monument that will be enjoyed by our community for years to come. The animal features were produced by a skilled craftsman in DeLand.

In keeping with the Mt. Trotwood Theme, the new entrance incorporates features representative of the Montana wilderness. Our local community members have shared that these improvements are appreciated and the children are especially excited by the playground equipment. 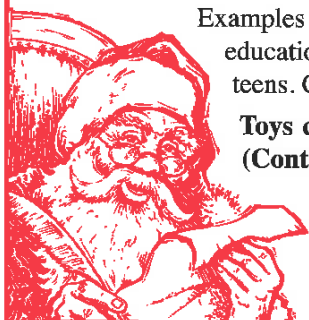

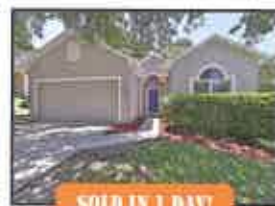

WATER PLANT UPDATES

During the October 12, 2020 City Commissioners Meeting a presentation from Veolia North America provided an update on the multitude of water and sewer projects currently under review and construction in the City. The members of the management company along with our city staff meet regularly and work together to provide these updates to the Commissioners and residents attending the meetings. These presentations are videotaped and are always available at the City website: www.winterspringsfl.org.

Water Treatment Plant #1 here in Tuscawilla has for several months been undergoing evaluations by outside water experts (CPH Engineering, Corolla Engineering, Kimley Horn Engineering and others) to determine interventions for improving the smell and taste of our tap water. The pumps in two of the four wells have been removed and cameras have been lowered to evaluate the well casings. Both pumps have been upgraded and the casings are intact. The engineers have determined that the well number 3 has a lot of sulfur in the water which is common in Florida. The plan is to evaluate a different depth for the pump so as to draw from a better source of water. Well number 1 currently has a desirable draw source and does not need to be addressed. The engineers have

developed a plan which has been approved by the state and should address the smell and taste of the water being produced by Water Treatment Plant #1. The plan calls for increased aeration of the water in both holding tanks and the installation of a new chlorination manifold which will allow more precise introduction of disinfectant during the water flow in the pipeline as opposed to having the chlorine introduced into the holding tanks. The experts have told us that these plant upgrades should improve the taste and smell of our water.

Improvements to Water Treatment Plant #2 located on the west side of town include major electrical upgrades and a new 450 KW diesel backup generator scheduled to be installed before the next hurricane season. The waste water (sewer) plants will be undergoing upgrades soon. The one located here in Tuscawilla is next to Sam Smith Park. The second plant is located on the west side of town. Due to the age of the facilities [50 years old], the engineers will need to draw down one tank at a time, remove the sludge, rags, plastic, and debris that accumulated in the bottom of the tanks and begin the refurbishment process. The aeration pumps at the bottom of the tanks have begun to fail and must be replaced. Work should begin shortly and keep in mind that there are 2 tanks at the Sam Smith Park location. They will use their best efforts to minimize odors and truck traffic. Please be patient as these vital upgrades are absolutely necessary.
