The Track Action Racing Club



1. Aims and objectives

The aims and objectives of the club are:

- To further interest in motoring and motor sport.
- To provide members with information, advice and assistance on matters connected with motoring and motor sport.
- To observe the local administration of the laws and regulations affecting motoring and motor vehicles, and to report any proposed local action or scheme to Motorsport UK
- To promote motor competitions in accordance with the Rules of Motorsport UK.
- To provide Members with such benefits and privileges as it may be possible to arrange on their behalf.

2. Membership

Membership will consist of officers and members of the club.

All members will be subject to the regulations of the constitution and by joining the club will be deemed to accept these regulations and codes of conduct that the club has adopted and the policies and rules of MUK.

Members will be enrolled in one of the following categories:

3. Membership Fee

Membership fees will be set annually and determined at the Annual General Meeting.

4. Officers of the Club

The officers of the club will be:

- Chair
- Secretary
- Treasurer
- Series Coordinator

Officers will be elected annually at the Annual General Meeting.

5. Committee

The club will be managed through the Management Committee consisting of:

David Beecroft Director

Vickie MacClinton Secretary

Only these posts will have the right to vote at meetings of the Management Committee.

The Management Committee will be convened by the Secretary of the club and held no less than two meetings per year.

The quorum required for business to be agreed at Management

The Management Committee will be responsible for adopting new policy, codes of conduct and rules that affect the organisation of the club.

The Management Committee will have powers to appoint sub-committees as necessary and appoint advisers to the Management Committee as necessary to fulfil its business.

The Management Committee will be responsible for disciplinary hearings of members who infringe the club rules/regulations/constitution. The Management Committee will be responsible for taking any action of suspension or discipline following such hearings.



6. Annual General Meeting

Notice of the Annual General Meeting (AGM) will be given by the Club Secretary. Not less than 21 clear days' notice to be given to all members.

The AGM will receive a report from officers of the Management Committee and a statement of the audited accounts.

Nominations for officers of the Management Committee will be sent to the Secretary prior to the AGM.

Elections of officers are to take place at the AGM.

All members have the right to vote at the AGM.

The Management Committee has the right to call Extraordinary General Meetings (EGMs) outside the AGM.

Procedures for EGMs will be the same as for the AGM.

7. Disciplines and appeals

All complaints regarding the behaviour of members should be submitted in writing to the Secretary.

The Management Committee will meet to hear complaints within seven days of a complaint being lodged. The committee has the power to take appropriate disciplinary action including the termination of membership.

The outcome of a disciplinary hearing should be notified in writing to the person who lodged the complaint and the member against whom the complaint was made within seven days of the hearing.

There will be the right of appeal to the Management Committee following disciplinary action being announced.

The committee should consider the appeal within seven days of the Secretary receiving the appeal.



8. Dissolution

A resolution to dissolve the club can only be passed at an AGM or EGM through a majority vote of the membership

9. Amendments to the Constitution

The constitution will only be changed through agreement by majority vote at an AGM.

10. Declaration

The Track Action Racing Club hereby adopts and accepts this constitution as a current operating guide regulating the action of

members.
