BE IT KNOWN, that on this 31 day of January, in the year of Our Lord, One Thousand Nine Hundred Eighty-four,

#### ARTICLE IX.

This Corporation shall have no capital stock, but shall be organized solely on non-stock basis.

Each owner's interest shall be based on a proportion,

The Villa Condominium Homeowners Association, Inc. shall have one hundred fifty-two (152) members who shall each serve on the Board of Directors, each representing the ownership of one (I) unit of The Villa Condominium, Inc.. Should one (I) person acquire ownership of more than one unit in said condominium then such person or the duly appointed representative thereof shall be entitled to occupy all the seats on the Board of Directors of said Association that correspond to that person's ownership of units in The Villa Condominium, Inc..
