Prices

Our services are billed as follows:

- Grant Proposal Writing: \$30.00 \$55.00 per hour
- Consulting: \$125.00 per hour

Additional fees for **travel**, **postage**, and **printing** may apply. The overall costs for researching, developing, and writing grant proposals typically range from:

- Foundation Proposals: \$1,500 \$3,000 (depending on the grant amount, with a 15% fee)
- State Proposals: \$5,000 \$7,000
- Federal Proposals: \$8,000 \$40,000

<u>Grant Writing Training and Consultation</u> \$100.00 per hour. Following our initial meeting, I will provide a scope of work. If you decide to write the proposal yourself, I offer:

- Training on researching grant opportunities

- Coaching and support


Fee Structure:

- Hourly Rate: A deposit is required to start, with the balance due before the release of the final work product.
- Flat Fee Per Project: Based on the proposal's complexity, existing information, and time constraints. A 50% deposit is required to begin, with the remainder due upon completion.
- Program and Strategic Planning: Provided on a flat fee basis.
- Retainer: A monthly retainer for a set number of hours, covering grant source research, notifications of new grant opportunities, proposal preparation, ongoing advice, consultation, and compliance reporting.

Expenses for all assignments are billed at cost plus time.
