These SMS Terms & Conditions describe how Kamerlengo LLC ("Kamerlengo," "we," "us," or "our") uses text messaging (SMS/MMS) to communicate with customers and other individuals who contact us.

Purpose of SMS Messaging

Kamerlengo LLC uses SMS/MMS messaging primarily for **customer-initiated communications**.

Our SMS service is intended to allow customers and other business contacts to send questions, requests, or other inquiries to Kamerlengo LLC and receive responses from our team.

SMS messages from Kamerlengo LLC may include:

- Responses to customer questions or inquiries
- Responses to requests for information
- Customer service communications
- Scheduling or appointment-related responses
- Follow-up information requested by the customer
- Status information related to a customer's request
- Other communications directly related to an inquiry or request initiated by the customer

Kamerlengo LLC does **not** use this SMS program for unsolicited text-message marketing or mass promotional messaging.

Consent to SMS Communications

When you initiate communication with Kamerlengo LLC by sending a text message to our published business telephone number, you consent to receiving SMS/MMS responses from Kamerlengo LLC that are reasonably related to your inquiry, request, or ongoing conversation.

If SMS consent is collected through our website or another method, consent is voluntary.

Consent to receive text messages is **not a condition of purchasing goods or services**.

Message Frequency

Message frequency varies based solely on customer-initiated inquiries, requests, and ongoing conversations.

Kamerlengo LLC does not send regularly scheduled or recurring promotional SMS messages through this program.

Typically, messages will only be sent as necessary to respond to a message, inquiry, request, or related follow-up communication initiated by the customer.

The number of messages received will therefore depend upon the nature and duration of the customer's interaction with Kamerlengo LLC.

Message and Data Rates

Message and data rates may apply.

Your wireless carrier's standard SMS, MMS, and data charges may apply to messages sent to or received from Kamerlengo LLC.

Opting Out

You may stop receiving SMS messages from Kamerlengo LLC at any time by replying:

STOP

After receiving a valid opt-out request, Kamerlengo LLC will stop sending SMS messages to that mobile number except as necessary to confirm the opt-out or as otherwise permitted by applicable law.
