### **Update on Fire Station Alerting:**

Director Schelstreet reported the following:

Received order confirmation from Honeywell. Information may come from them instead of U.S.
 Digital. No information from installer.

### **Director's Report:**

Director Schelstreet reported the following:

- The parking lot will be paving is complete.
- South Street Tower has had some work done to grounds. The trees were trimmed. A weed barrier and gravel were put in. More work will be done next year.
- Fence/Security concept, survey, and engineering contract have been done. SEPD is going through accreditation. Lack of security is always mentioned in accreditations.
- StarCom All APX radios need to be tuned every 2-4 years. The cost is \$75 per radio. Will work with KaneComm. May be able to have Andy Baumann do the tuning. All radios will need to be gathered and tuned.
- There were some radio management issues due to an updated that eliminated Wi-Fi connection ability.
- AT&T has contact information for fiber. Have a project manager, area representative, and sale person. If you already have fiber and a switch, it may just be a plug in.
- ETSB Radio Study Site visits are done. Andy Baumann has been taking noise readings on the tower and recording the information. Radio backups will move to South Street. Will share a backup server with KaneComm.
- State keeps advising of a surplus surcharge payment, but none received yet. Still no information on surcharge distribution changes.

# **Deputy Director's Report:**

Absent. Director Schelstreet reported for Deputy Director Marz:

• GPS enable on StarCom radios. If radios are lost, this would allow locating. Director Schelstreet will check into this.

### **CAD Analyst Report:**

Tammy Kleveno reported the following:

- New functionality in IAmResponding app that works with RapidSOS. It is able to breadcrumb to actual location. Will be getting a demo on this. There is no way to put What3Words into it. Cannot cut/copy. Must be manually entered. She will send out information on this.
- The Freedom App will be moving to apple and google play. It will be a hidden app. The icon will change soon. She will let everyone know. Fermilab now has five iPads with the Freedom App.
- St. Charles needs box cards.
- She is going through the tri-cities to see if there is an issue with the engine/truck.
- CAD Hazards please distribute and review.
- Director Schelstreet added that the Hub to Hub (CAD to CAD) will cost \$68,000 for both sides. Will add KaneComm first. Tyler was \$80,000 for one side to receive. Approximately \$15,000 per year for a subscription.

## **Training Coordinator Report:**

Andrew Kunstler reported the following:

- Kayla will be fully trained soon. One more in training. Another starting at the end of October. We will be fully staffed then.
- There will be new nature codes at the beginning of November.
- Active Assailant Response Would like to separate stab/gunshot code. Tammy Kleveno stated
  that it would be similar to downgrading an accident. We can upgrade if multiple victim, etc. If it
  is an active incident, the nature code could be changed to enable more response. Everyone
  respond with what you would want on an upgrade. Kleveno will send out downgrade
  information.

Kristina Rohrbach reported the following:

• The z-axis is live in Rapid SOS. Only working on android phones right now. Does not work correctly yet. Will eventually survey all buildings.
