Update on COVID-19:

Deputy Director Marz reported the following:

Update on StarCom:

Deputy Director Marz reported the following:

- Met with Motorola regarding the 10th Street tower location. The two proposed locations have issues. There is a sewer line at one and a zoning issue with the other.
- Tim Richardson from Motorola informed us that all lapel mics would be reset to the best settings. Please bring four radios to Station 1 at 9am for reprogramming and testing.
- BC Mauthe stated that our radios are five updates behind on firmware. They need to be all on the same version for testing. He will ask Steve Fiedler about this.

Update on Basement Project:

Deputy Director Marz reported the following:

 Reef Construction started work on October 5. They trenched the south and west walls and removed the flooring in the basement. They are on schedule and should be done by the end of November.

Update on Staffing:

Deputy Director Marz reported the following:

• One trainee will be released after phone and police training in December.

• Two more trainees are currently in training. Another is starting on November 30.

Board-Up Applications:

Shevon Sherod-Ramirez asked if there were any changes to be made to the Board-Up Policy form 2020. There was none. Applications will be available in mid-November for 2021 on Tri-Com's website.

911 Eye Software:

Deputy Director Marz stated that 911 Eye software could send caller a text that will activate their phone to enable them to send live feed, photos, etc. Will be looking into implementing this by the end of the year. This is a web-based program. Information is stored for 30 days on cloud. If anything needs to be held longer, need to notify prior to the 30 days.

CAD Report:

BC Mauthe asked if the emergency activation worked in VHF. DD Marz stated that it does not and has always been digital. DC Einwich stated that it did not work on the old radios and that Steve Fiedler had said it was part of the profile for radios. This needs to be tested. DD Marz will check, but believes it will only activate on one channel. BC Mauthe will follow-up with Dir. Schelstreet. He also had questions on where the activation goes when they are at a DuComm incident. They will go to black for now because they cannot rely on the DVRS.
