NEW BUSINESS

Approval of Parking Lot & Security Project Bid:

Director Schelstreet stated that Anthony Bryant from WBK Engineering was in attendance for any questions. There were 7 bids packets received. Abbey Construction came in with a bid of \$265,320. This was below the engineer's estimate.

A motion to approve the parking lot and security project bid of \$265,320 from Abbey Construction was made by Alderman Bruno and seconded by Alderman Malay.

Director Schelstreet stated that \$100,000 towards the project would come from the DECO grant. May be able to get some additional funding from the ETSB. The parking lot will be about 7,000 square feet

and have 17 parking stalls. For accreditations and audits, security is always an issue. This will take care of that. Additional drainage is included.

The motion passed by roll call vote. (9 yea, 0 nay, 2 absent)

Other Items:

Chief Hanson stated that the IGA draft was sent to the three legacy agencies. There is some concern with getting approval. The consensus is to have a workshop with the attorneys from the three cities, Attorney Reinke, and board members.
