RESOLUTION NO. 2018-007

RESOLUTION AUTHORIZING TO WAIVE ANY FORMAL SOLICITATION FOR BIDS AND IN LIEU THEREOF, UNDER THE PURCHASING ORDINANCE, PURCHASE 327 UNICATION G5 PAGERS AT A COST OF \$197,671.50 FROM MINER ELECTRONICS WITH FUNDS FROM THE AFG GRANT.

BE IT RESOLVED BY THE BOARD OF DIRECTORS OF TRI-COM CENTRAL DISPATCH, AN INTERGOVERNMENTAL COOPERATION AGENCY OF THE CITIES OF ST. CHARLES, BATAVIA AND GENEVA, ILLINOIS, as follows:

SECTION 1: The City of St. Charles was awarded monies from AFG (Assistance to Firefighters Grant Program), and obtained bids for above mentioned equipment. Tri-Com in partnership with the City of St Charles has entered into a contract with Motorola for the remaining equipment necessary to implement and complete the StarCom21 project; and is looking to enter into this contract with Miner Electronics so all equipment will be funneled through Tri-Com to the respective fire agencies that were named in the award for the grant.

SECTION 2: Be it resolved that the Board of Directors is authorizing to waive any formal solicitation for bids and in lieu thereof, under the purchasing ordinance, purchase 327 Unication G5 Pagers for at a cost of \$197,671.50 from Miner Electronics with funds from the AFG Grant.

SECTION 3: This Resolution shall become effective from and after its passage as in accordance with the law.
