Director Report:

Director Schelstreet reported the following:

- Tri-Com has a board-up policy for fire agencies. We will use this for any police agencies that need board-up services. Shevon will send out policy to all.
- CESSA will probably not be completed by July 1. We are in Region 9 for IDPH. The state had PSAPs complete a survey. Any changes to EMD will have a cost associated. New EMD cards would determine when to send a call to 988. They asked about CIT trained dispatchers. They may be looking to have dispatchers complete 8-hour CIT training.
- AID contracts have ambulances respond to 10-96 calls, call AID, then they respond. Southern Fox Valley is writing new procedures to allow transport to non-traditional destinations, possibly, counseling offices, treatment facilities, etc. Dir. Schelstreet will send out survey to all. A meeting yesterday, they discussed procedures for data collection, expectations of command and officers, when calling AID there will be questions dispatch will not be able to answer. Encouraging all to attend all CESSA meetings. All subjects are discussed at meetings not just the stated subject. They have no funding to implement and are looking for ways to use law enforcement and dispatch assets.
- Discussed possible disposition codes or double disposition codes. Tammy will send these out.

Deputy Director Report:

Deputy Director Marz reported the following:

- The Prepared 911 information was sent out. There will be a presentation at the Joint Ops Meeting. Basically, it is a web-based interface for RapidSOS. Live feed of video, media, etc. Opens up cell phones.
- Andrew Kunstler asked her to let all know that he will be reaching out to schedule training on What3Words. He has completed this with all fire agencies.
- Scott Mechowski stated that warrants will stay in LEADS until Tri-Com is notified by the agency holding the warrant to remove it
- Discussed Paul 10 and Robert beat. When there is no Paul 10 unit, east/west would take over. DD Marz will send beats to Majewski. St. Charles wants a 10 beat. Kristina will create a sub-beat map for St. Charles.

- Tri-Com purchased license to take all keyholder information and move to new database. All reports were not running. CAD Keyholder information is now outdated.
