**Director Report:**

Director Schelstreet reported the following:

- Trying to track radio busy signals. If you get a “bonk”, please let us know. There were no towers added when KaneComm joined StarCom. This added capacity.
- Working on fencing and the lease. New plan to add parking on the west side of the building for staff. Public parking will remain where stalls are now.
- Meeting with consultants on Friday to discuss non-union compensation.
- Asking the Board to approve a new part-time QA/QI position.
- Radio Management is consuming a lot of time from DD Marz. Will be coming up with a plan. Non-emergency work will be done at specific times.
- One Solution CAD will continue to be sold. Installed the 64-bit version. Cost savings to stay with this product.
- Met with fire and IT staff to discuss Fire Station Alerting. Will create our own network. There will be a central ethernet fiber line to each of the tri-cities to connect and then it would be connected to each location. It will be about \$300 for each per month. This will go to the July Board Meeting for approval.
- Received two ETSB surcharge checks.
- CrowdStrike, cyber security, is up and running.
- CESSA meetings have had low attendance since extending deadline.
