## **Director Report:**

Director Schelstreet reported the following:

- There will be a network established between Tri-Com and each city.
- Working on lease with ST. Charles for Tri-Com building.
- The parking lot paving project is ongoing. The Board will be voting to approve extra work.
- Senator DeWitt will be requesting SafeT Act funds for security fence.
- A compensation study was done for non-union staff. Board will vote on this at the next meeting.
- Staffing two in backgrounds. This will bring it to 21 dispatchers.
- Tri-com is now geodiverse. KaneComm is on a different phone switch.
- Radio Study has been approved. WE are 6 months behind. There may be a special meeting for this.
- Should be receiving a supplementary check from ETSB. A study is being done on how funds are distributed.
- Still working on structural documents.
- No new CESSA information.

## **Deputy Director Report:**

Deputy Director Marz reported the following:

- We are set up on Flock through St. Charles. The directive will be reviewed and she will send it out final version to all.
- Would like to create a police channel guide. There is one for fire. Mary Robertson stated
  that it would have squad, phone numbers, etc. It will probably be updated on a quarterly
  basis. All agreed to proceed with police channel guide.
- Please complete the bonk form when you have issues. This will help to show issues in a particular area. The bonks put you in a queue. Each time you hit the button, it will send you to the bottom of the queue.
- Please schedule new officer sit alongs with Andrew Kunstler.
- Ecker Center wants to pitch an idea.
- Radio Management is on hold. Motorola has broken our connection to their server.

#### **CAD Report:**

CAD Administrator Kleveno reported the following:

- CAD entries for hazards, officer safety, etc. can be added if it is an emergency. Need to have command staff signature. Please let your staff know not to use the premise alert form.
- LEADS 3.0 will come out soon for MCTs.
- Mary Robertson stated that agencies can send new officers to Tri-Com for about a 4-hour sit along to review directives, CAD codes, etc. Great for OIC, new officers, and veteran officers.

#### **GIS Report:**

GIS Administrator Kristina Rohrbach reported the following:

- She attended the ESRI User Conference. ESRI is doing more with public safety.
- Z-axis will show elevation and a +/- of location.

## **Training Coordinator Report:**

Training Coordinator Andrew Kunstler reported the following:

- He stated that the driving complaint response is currently to assign a beat officer. Could we move to information for police?
- He asked if they needed to be notified of lower priority fire/EMS calls. All agreed to keep them informed on all medic calls. Mary Robertson stated that BFD is down five medics right now, so there might be delays.
