- ATT & Intrado will be replacing POTS lines with SIP lines. The order has been placed.

- Sprinkler plans approved for water project.
- Construction on new wall for GIS area will start on August 22.
- Upcoming projects include console cleaning and painting.
- The microwave issue was resolved with a new vendor. Fire South for North Aurora and Sugar Grove is reconnected.

- The stated refunded \$353,000 from the Next Generation 911 wireless funds that were diverted. The Board requested looking at capital projects. This may include upgrading the CAD. Security is another project. Mission Critical Partners was selected for the project to include fencing, rerouting the roadway, cameras, polices, protocol.
- Board is looking at compensation and compression issues for non-union positions. City of Geneva will be doing a compensation study. The Board agreed to separate from Geneva in regards to compensation. This will go into the structural documents.
