Although the scholarship covers all registration fee and tuition, **parents will be responsible for** a small monthly payment to cover a small portion of recital fee and costumes.

In order to be eligible for a scholarship and to maintain the scholarship the following must apply:

- 1. Submit this completed application to tempoperformingartscom.
- 2. Immediately following the notification of a scholarship being granted, you will register your dancer for the 2024/2025 dance season.
- 3. During registration you will be required to input a credit or debit card number to keep on file to cover the monthly parent payment. Your monthly payment will be automatically withdrawn the 1st of the month (August 2024 to May 2025). You are responsible for any late fees; late fees are not covered by the scholarship. Non-payment will result in loss of scholarship.
- 4. The student will maintain good discipline during all studio events, including but not limited to class. We expect scholarship students to be respectful, have good work ethics, and to follow all studio rules and policy.
- 5. Consistent tardiness or absence from classes, for reasons other than serious illness, injury, or family emergency, may result in the revocation of the financial aid scholarship.
- 6. Financial aid scholarships may be revoked at any time for a student or parent's misconduct or failure to comply with Tempo Performing Arts established policies.
