Activities

The activities committee has planned many community functions that include all ages. As usual please check out the details below or at the LF website. One of the highlighted activities is the upcoming Cinco de Mayo celebration on Friday May 5th. There is a lot of good food and drink preparation going on so I hope to see you there!

Communication

To improve communications between the board and residents we will be providing monthly meeting agendas a week in advance. For those few residents that do not have email, the agenda and this newsletter will be sent to them by mail. We are also planning to add a waterproof box to the "book stand" down by the pond that will contain similar information. We will let you know when the box is completed and ready for use.

Grounds

A detailed map of our common areas has been provided to the landscaping company to instruct them on the areas that need their mowing attention. If you feel that they "missed a spot" please let us know.

Pond

There is a conference call scheduled this week with board members, our local state senator and representatives from the PA DEP Department of Dam Safety to discuss our violation notice.

The yellow "goose away" solar powered light bulb, that was recently replaced, drown, shorted out and is currently inoperable. A free replacement one is on order.

Pools

The pool was drained, cleaned and a second coat painted last week. The new paint will need a few dry days to cure but as of now it looks like it will be open in mid May, weather permitting. With this second coat and with the repainting of the warnings around the pool deck, the pool should be in great shape and looking great this Summer.

Investigation of the toddler pool plumbing problems was started last week. If the plumbing can be repaired, our filtration and chlorination system will be have to be upgraded to meet new Allegheny County health department requirements before opening is permitted.

The daily pool hour from 10:00 AM to 11:00AM has been opened up to all residents based on a unanimous board decision. Additional rules and regulations were put in place to ensure a "quiet hour". The new rules will be posted at the pool and in our Rules and Regulations but are as follows:

Quiet Hour Pool Rules - 10:00 AM to 11:00 AM

- 1. All residents and guests are required to refrain from any activities that may disturb the quiet hour.
- 2. This includes, but is not limited to:
 - 1. Playing loud music.
 - 2. Shouting or yelling.
 - 3. Squirt guns, pool toys, sports balls or the like.
 - 4. Jumping into pool or splashing excessively.
 - 5. Blocking the entry steps to prevent safe access.
- 3. Guests who are asked to leave the pool area for violating the quiet hours policy may be subject to a fine and/or loss of pool privileges.

Budgeted Projects:

As weather permits, residents should see a flurry of activity as we implement the large budgeted projects at Lakemont Farms. This month:

- the white fences will be cleaned and painted.
- the rotted, dilapidated wooden wall along the tennis court will be replaced with a **new stone wall** that will match the one in the parking lot.
- the **tennis court** will be repaired and re-lined to create a multi sport area to include basketball, pickleball and tennis.
- we will iron out the details in regards to the new **playground gates**, and relocation of the basketball hoop in preparation for the installation.
- we are obtaining estimates to repair the **spur roads** and possibly the road to the clubhouse. (causeway)

I know that is a lot of activity at one time, but we have been busy for months getting all of these improvements in line for completion. We will advise you of any special meeting dates and keep you posted on the progress of each project throughout the year. If you have any questions or comments please let us know via the website email or just drop us a line.

Our next board meeting will be Tuesday May 30th at 6:30pm. I hope to see you there!
