
### Annual Meeting Minutes (continued)

### Bylaws Citizens for Backus/AB Bylaws Sections

Article IV, Section 4.1 Board Role, Size and Compensation:

The Board is responsible for overall policy and direction of Citizens for Backus/AB, Inc. The Board shall have up to 15 and not fewer than 11 members. No Director may receive compensation for his or her service as Director. However, nothing contained shall be construed to preclude any Director from serving the corporation in any other capacity, or receiving reasonable compensation therefore.

#### Article IV, Section 4.3 Board Elections:

Election of new directors or re-election of current directors to a second or third term will occur as the first item of business at the annual meeting of the corporation. Directors will be nominated by a majority vote of the current Board of Directors. Directors may also be nominated from the floor at the annual meeting.

#### Article IV, Section 4.5 Terms:

All Board members shall serve three-year term, and are eligible for re-election. The initial Board of the corporation will have staggering numbers of terms to prevent an entire turnover of the board at one time.

### Alexander Baker School Update



Citizens for Backus/AB and KOOTASCA Community Action received word on January 28, 2022, that Minnesota Housing has selected the Alexander Baker Housing Project for an allocation of Federal Low-Income Housing Tax Credits (LIHTC). This funding, along with other sources, will fully fund the proposed \$12.88 million Alexander Baker Housing Project.

This approval brings to life the adaptive re-use of the historical Alexander Baker school for affordable housing. Lois Lundin, Executive Director for Backus, stated, "Citizens for Backus/AB is thrilled with the Minnesota Housing board's decision. This fulfills a vision that started more than 20 years ago when local citizens started efforts to save the E.W. Backus and Alexander Baker school buildings from demolition. We see this as such a positive move forward for our northern Minnesota communities!"

The adaptive reuse of the Alexander Baker Building is being undertaken and co-developed by KOOTASCA Community Action and Trellis Co., a Minnesota nonprofit developer of affordable housing. Affordable housing is housing that a household can afford while still having money left over for other life necessities like food, transportation, and health care. Housing is considered affordable for a family when it costs no more than 30 percent of a household's income.

"As a rural border community, the national housing shortage has hit International Falls particularly hard over the last several decades, especially for working-class families, renters, and seniors," said Isaac Meyer, KOOTASCA Housing Development Director. "So we are incredibly excited to help alleviate that shortage, while also revitalizing a core part of the city at the same time. We have so

much potential here, and I hope this project will encourage others to invest in this community."

It is anticipated that construction could begin in fall or winter of this year. When finished, the project will provide 27 units of affordable housing for rent, including 4 one-bedroom units, 16 two-bedroom units, 4 threebedroom units, and 3 four-bedroom units.



#### Lois Lundin, Executive Director

2021 was a great year at Backus Community Center. Please review this summary of some key accomplishments and happenings from 2021.

#### Quarter One:

- City and County funding for the Backus Community Center was announced and received for the 2021 year.
- The 2021 "Feed Just One" fund raising campaign for Community Café was very successful. The campaign closed after raising \$50,865.00.
- The new walk-in freezer installation was completed and the freezer was in use.
- LIFT, a fitness studio owned by Jenna DeBenedet, opened in the lower level.
- Grant funding from the Minnesota State Arts Board was awarded, allowing Backus to start the Hidden Talents programming with KCC-TV.
- New, touchless soap and paper towel dispensers installed throughout Backus.
- Updated security lighting installed over the East entrance.
- LED floodlights installed on the NW and SW corners of the Backus roof.
- LED lighting installed by the entry door in the alcove.
- LED light installed by the entry door at the ramp.

#### Quarter Two:

- All fire safety equipment, kitchen, and general building inspections completed on schedule, and fire safety information was shared with all staff and tenants.
- The spring roll making and sale was a tremendous success!
- The Garden Club received a grant for four round raised beds from the Minnesota Horticulture Society. This included all soil, fertilizer, seeds, and plants.
- Volunteer appreciation dinner was a great evening of recognition and appreciation for our many volunteers.
- The Summer Food Program started in June.
- The project to line the lower level hallway and stairways to the first floor with fiberglass sheeting was completed.
- Backus and AB building clean-out/simplification continues.
- Boiler project and electrical transformer relocation project planning started.
- Hired Jeff McHarg for Backus sound and lights.
- Koochiching County approved the sale of 25' of property to Backus. The property line for Backus now extends 25' to the west between 3rd and 5th streets, toward the Forestland building. Backus will retain ownership of the entire strip for parking.
- Memorial for John Faith, one of Backus's original board members since 2002, was held on June 16, 2021.

### Executive Director's Report (continued)

#### Quarter Three:

- A representative from the University of Minnesota Extension Community Programs Horticulture Society came to the Backus garden for a site visit.
- Backus reached an agreement with the Recreation Commission regarding fees for the use of the gymnasium for the Junior High basketball season.
- Mitchell Erickson was hired to help with filming for KCC-TV. Requests for coverage from community events and meetings continues to grow.
- New handrails, designed and crafted by Dan Benedix and Kari Gansch were installed along the two sidewalks on the east side of the Backus building. LED lighting was also installed in this area by Howard Davis and Josh Urban of Davis Electric. Both measures provide improved safety for our guests who utilize the handicap accessible sidewalk and the stepped walkway.
- Digital piano purchased for the Backus Music Program.

#### **Quarter Four:**

- The Kimball grand piano was donated to the Faith United Church.
- A rental agreement reached for a new Daycare Center to open in Backus in 2022.
- The local 4-H organization condensed its occupancy to just one room in Backus.
- Ruby's Pantry announced a "pause" in its food distribution service in order to review and restructure processes and align resources. The program will resume operations in March 2022.
- The 2022 Feed Just One fundraising campaign started in November 2021.
- Backus is partnering with the local Veteran office and Koochiching County Historical Society to have a permanent Veteran memorial showcase.
- Mighty Mustangs Wrestling Club rented space in the lower level of Backus.

Over the course of the year, Backus continued with preparations for the anticipated sale of the Alexander Baker building. Grant applications were submitted for funding requests, and all required reporting was completed. The Summer Food Service Program and Community Café continue to be strong food programs for our community. The performing arts are alive and well and audience participation at events is getting stronger. Our membership numbers are strong and are on the rise. Everyone at Backus is looking ahead to 2022 with excitement. We are positioned for continued growth, and our Board and staff are fully engaged. We have very dedicated groups of volunteers. Life at Backus is very busy, but it is very, very good!







**Feed Just One -** *Fundraising for Community Cafe* - Donation total was approx. \$51,000. This is now an annual fundraising event.

**COVID Funding** - Backus qualified & received funds for Payroll Protection Program. Backus also received COVID funding from KCDA and installed new lighting and safety railings on East side to help clients picking up Cafe dinners.

**Mask Mandates** - Backus recommends visitors wear masks when in building common areas. Backus will follow State guidelines set or changed as needed. Signage is placed throughout building.

Land Transfer to Backus - Purchase of the West 25' of parking area from Koochiching County Forestland Building This area goes from South curb to North curb & will give Backus additional parking once AB project has started.

National Registry Historic Plaque - Brass Plaque was donated and placed on SE corner building.

**Vets Memorial Showcase** - The Veterans Service Office is working with Backus to create a permanent display in the East main floor hallway for veteran's memorabilia that families/ individuals would like to contribute to display. Financial costs will be paid by Veterans Office.

**Backus Music Program** - Board approved the formation of Music Program, dedicated space for music practice, lessons, program coordinator position, music performances, collaboration with Rainy Lake Community Orchestra, music teachers, and other related groups.

**Piano Donation** - Kimball Piano that was a donation to Backus has been donated to Faith United Church, donation plaque will remain on piano. Piano was not being used & Faith United greatly appreciates donation.

**Energy Analysis** - MN Power conducted an energy audit and recommended several changes including use of standard equipment thru-out building, LED lighting starting with main floor in areas most

frequently used. We will change to LED as funds are available.

### **Endowment Fund**

Since 1937, the historic Backus building has been a community gathering place, first as a school and, since 2002, as a Community Center playing a vital role in the lives of many who live in and visit the area. Now an effort is underway to ensure the same holds true for generations to come.

Citizens concerned with the sustainability of Backus and its Community Center programs gifted funds to establish an endowment fund. A committee was formed to outline plans and goals for the fund and its future. The endowment campaign is an effort to raise \$1 million in three years. Major donors have already contributed significantly to the fund.

The fund is established to provide effective and responsible stewardship and to ensure expansion of community work. The fund can accept gifts and bequests in wills, charitable trusts, gift annuities, assignments of life insurance, and transfer of property (cash, stock, bonds, real estate, etc.). Backus endowment will accept pledges for annual gifts. Contributors can dedicate gifts in memory or honor of a family member or friend. If physical assets are received, they will be liquidated as outlined in the fund's by-laws.

Once the three-year goal of \$1 million is reached, earnings may be expended to fund programs and projects that help fulfill the Backus mission, such as:

- Outreach programs to address community needs and opportunities in International Falls and Koochiching County.
- Ensuring the preservation and re-use of the historic Backus building continues in perpetuity.
- Allowing flexibility in times of economic down-turns or major crisis.

The Endowment Committee is planning to kick off a campaign to share information with the public and potential donors in the first quarter of 2022.

### **Building and Grounds**

#### The Boilers

The boilers were drained in the spring and there were no issues to report with the shut-down process. Sprint maintenance was completed as scheduled and the boiler room was quiet for the summer months. The boilers were fired up in late September without issue. A "pig-tail" valve had to be replaced in December. This type of valve has failed in the past when sediment plugs the valve. The replacement took minutes and boiler number two has been running smoothly since.

It is the intention that this will be the last season of operation for these two large boilers. A team is partnering with a local contractor to design a new system and to install a new, more efficient boiler system. Backus will continue to heat the building with steam.

#### Lower Level Storage Units and Hallway

A storage room in the southeast corner of the Backus ground floor has been vacated. A smaller storage room next to that unit has also been vacated. The partition between the two rooms has been removed to make a large rental space for the Mighty Mustangs Wrestling Club. The team is happy to have a large, industrial looking-cool space for wrestling practice.

Another room in that area of the lower level was once the school's industrial laundry room. The items that were stored there have been removed, and the large washer and dryer have been disconnected. It is currently being used as a learning lab for the garden club.

The Borealis Bards have also moved their storage inventory to a unit in the Backus lower level.

#### Clearing Items Out of the A.B. School

Work continues to clean out the items from the Alexander Baker School that need to be removed. Some of the items have been sold or given away, and things that need to be thrown away or recycled are handled appropriately. The Ruby's Pantry leadership team is working to obtain external/ offsite storage for the items that they need (shopping carts, wagons, freezer blankets, etc.).

#### The Costume Room, Backus second floor

The Borealis Bards took inventory of and organized the costumes and props that were stored in their storage room on the second floor. Backus will remove its items that are unnecessary and will make room for storage for necessary items.

#### Stairway Walls

Harry Batdorf continues with his work to cover the lower part of the walls in the northeast and northwest stairways between the first and second floors of the building. These white, textured fiberglass sheets are being cut to an exact fit and then are firmly placed to stabilize the failing plaster on the walls. This project started as a temporary fix until Backus is positioned to have the walls returned to their original state. This is a tremendous improvement and we are grateful for Harry's detailed work.




### Arts and Programming

Business discussed and conducted throughout the year included the following:

- The Backus Performing Arts Season's first performance was held on Friday, October 8, 2021 with a performance by Chris Kroeze. The Borealis Bards performed <u>Pinocchio</u> on October 22, 23, and 24. Seth Mulder & Midnight Run performed on October 26. All of these performances were well received, and the audiences enjoyed having the opportunity to come to live shows again.
- Various pieces of local artwork were displayed in the Backus showcase. Some of the highlights include: Jim Lucachick set up a beautiful display to share his love for fishing in Northern Canada and Alaska. He included story boards of the expeditions, the fish that were caught, and of necessary life skills for people in those remote regions. Bob Marquardt shared his collection of duck prints and hand carved decoys. Local photographers displayed their works; it was very interesting to see the world as they see it through the viewfinder of their cameras.
- A display of local tributes was set up in the auditorium for Memorial Day. People brought photos, memorabilia, and story boards to share their loved ones' stories and to commemorate their people's years of service in the Armed Forces.
- Backus Community Center partnered with the Faith United Church for a "Fall Fantasia" production in November. This was a delightful performance with music provided by several local artists.
- In December, the Rainy Lake Community Orchestra hosted a Holiday Concert for the community. Music was performed by several musical groups, and there was a community "sing-along" afterward. It was a fun night for the community, and there was even an indoor "snowball" fight!
- The local photography club, Northwoods Shutterbugs, held a fundraising show for Backus. They displayed their artwork, had photographers on site to help with questions, and had prints for sale. It was a wonderful show and was well attended by local people. Backus was honored to be the site they chose to show their work; they put a lot of work into this show! We truly appreciate the support that they gave to Backus!
- The remainder of the performing arts season consists of concerts by Shirts & Skins, PARADIGM (Gary Hooker and friends), and The Shane Martin Band. These artists will perform in 2022.

### **Event Coordinator Report**

The Event Coordinator position has been managed by a number of people in 2021. Judy Medeiros completed the Event Coordinator tasks until her departure in October. From that time on, all tasks were coordinated by the Backus staff.

The Event Coordinator continues to be responsible for catering and rental services. The Event Coordinator works with clients from start to finish on all events including contracting, pricing, arranging catering services, setting up all equipment and facilitation needs. He/she is the front line service person for all happenings in Backus. The Event Coordinator is also a key contact for all volunteers. Volunteer activities and hours are carefully recorded for all reporting needs.

Health and safety guidelines continued to drive the way events at Backus happened. Social distance spacing was determined for auditorium seating. Room capacity was calculated to ensure safety. Due to the many pandemic restrictions, the public has also become more aware of the opportunities that are available at Backus because of the large spaces that can be used for groups that are larger than other venues can accommodate, so we are often the venue of choice. Backus continues to promote its electronic equipment inventory which makes big screen tv's, cameras, microphones, and computers available for a fee to organizations to utilize ZOOM and WebEx to facilitate meetings, court hearings, and training sessions.

Backus is continually looking for ways to bring services to people in our community that are needed and value added.

### **Borealis Bards**

Oh, what a year. What was begun must be redone! In March of 2020, less than a week before the first performance, the rise of COVID-19 led to the mothballing of our Junior Bards production of Pinocchio, directed by David Griffith. Fully 17 months later, Pinocchio was relaunched by new directors Breanna Johnson and Gavia Yount with a few other changes in cast and crew. Despite concerns about fluctuating pandemic cases, on October 22, 2021, the show did go on!



### Koochiching County Community Television

KCC-TV continues to bring viewers local meetings consisting of Koochiching County Board of Commissioners, Koochiching Economic Development Authority, Airport Commission, North Koochiching Area Sanitation District, Int'l Falls City Council, Ranier City Council/Committee of the Whole, and ISD 361 School Board. The channel receives sporting updates from Timm Ringhofer and George Fraik with their weekly submitted show "The Sports Rap with George & Ringer." Local school sports are covered by KGHS/KSDM through Your Live Event on YouTube. They are streamed for KCC-TV viewers on Midco Channel 7, as well.

The "What's Happening at..." programs featured Backus events such as spring roll preparation/ tutorial and the harvest dinner preparation. A class of 5<sup>th</sup> graders, from Falls Elementary got to show off their ecosystem dioramas. Indus school invited KCC-TV to their classrooms for a day of cooking, poetry, art, music, gym, gardening and shop class projects. The summer season brought the return of Concerts in the Park. "Open Range Concert Series Up North" premiered this past summer. The first round of "Hidden Talents" is coming to an end. Programs featured a number of music makers, a weaver, an avid fisherman/taxidermist, and a woodworker extraordinaire. The series should grow as local talent continues to provide.

As of February, KCC-TV has uploaded over 200 programs on the YouTube channel. Some are short snippets of local life from a gardener giving a tour of her gardens, volunteers singing Valentine telegrams to raise money for those in need of housing, and eccentric artist painting a mural on a local restaurant, to a coat drive for area youth. While others are longer, showcasing community or-chestra concerts, a farewell to a friend moving away, celebrations of life for loved ones who have passed, and veteran's suicide awareness. From proms, graduations and award ceremonies, school concert to parades, KCC-TV was there behind the camera.

### Ruby's "Pop-Up" Pantry

Ruby's Pantry opened its doors in International Falls in July 2015 and continues to have a very strong presence in the Borderland communities. The foundational truths behind Ruby's Pantry remain the same. There is only one qualifier for all guests to meet in order to participate in Ruby's Pantry. **If you eat, you qualify. Everyone is welcome!** 

On the second Monday of each month, the Ruby's Pantry truck arrives at Backus and unloads an average of 15 tons of food to be distributed to area residents. The entire process happens within hours. All of the food is brought in to the auditorium, sorted, inventoried, prepped into "shares", and then sent out to guest's vehicles. Area organizations who also have needs for food items come at the end of the distribution to collect items that are left. Waste is minimal.

The 2020 pandemic brought changes to the International Falls Ruby's Pantry distribution process. In order to keep guests and volunteers safe, the distribution changed to a curb-side drive-through service. Volunteers gather items and load "shares" into shopping carts, which are then wheeled outdoors and loaded into guest's vehicles. This service has been received very well by both the volunteers and the guests. There are fewer volunteers needed for this process; the operation runs efficiently with about 50 volunteers. The drive-through service is very beneficial to the guests. People who have physical limitations don't have to leave their vehicle, and parents of families can come without having to find childcare or without having to keep their children occupied in the auditorium while they wait to go through the food line.

Food shares are very generous and contain quality items that help keep families pantries stocked. Pallets of fresh and frozen produce, milk and dairy products, meat, bread, paper products, and a host of other grocery items fill the semi-truck. Occasionally there are some bonus items, too; fresh flowers, potted herbs, umbrellas, and toys for the kids have been shipped to be handed out to the guests.


While the Ruby's Pantry food distribution took a "pause" in December of 2021, the group looks to resume operations in March of 2022. There will be a few new leaders involved, which will bring fresh looks to old processes, and efforts to make things even better.

Many people come to Ruby's and pick up one or more shares of food, and then they share the food with others. It is common to hear about people who gather with their neighbors and divide the food amongst households. This is a wonderful way to get food out to others who cannot come to Ruby's for one reason or another. One guest wrote, "I take food to my neighbors. We live in a very rural area in the county, and we know a lot of people who don't have much. I'm glad that my husband and I are able to donate a few shares and that we can bring food around. People are so surprised when there are flowers, too!"


Benefits to our Northern Minnesota communities don't end with the food that is distributed. Each guest donates \$22 per share of food that they receive. Of that \$22, \$2.20 stays local. Benevolence dollars are allocated to organizations across Koochiching County. To date, Ruby's Pantry has given more than \$32,000 to area charities and non-profits. Additionally, food and supplies from monthly distributions are given to food service organizations such as the Senior Center, Food Shelf, Alano Club, RRCC Pantry, and area churches.


### Community Café

The Backus Community Cafe addresses hunger and food access issues in our community by providing hot, nutritious meals each Tuesday and Thursday evening. This program does not impose any qualifying requirements on its guests. Everyone is welcome. Food is prepared fresh daily and is available for pick-up in a very efficient and timely manner. The quality of the food is excellent, and the variety of the menu selections is very good. The portions are generous. Milk is always included, and many times there is fresh fruit. Walk-ins are welcome; there is always plenty of food. Of equal importance to the meals that are served, all people are treated with kindness and respect.

While the generous portions of good food are important, the meals are just one component of addressing hunger and food needs in our community. Backus has worked hard to soften public perception issues around the word "need". A common misconception is that only people who don't have financial means should be coming to Community Cafe. Backus sees this very differently. In addition to those who might be dealing with financial challenges, we see many people with various issues who are simply trying to make all ends meet. We serve people who are working through various mental health or substance abuse/recovery issues. We serve people who are living in places where they don't have a means to prepare food. We serve people who are struggling through day to day life because of the social effects of the pandemic (isolation, rising costs of products and services, services that are difficult to obtain or that are simply no longer available, etc.). We have many people who come to pick up dinner and deliver to elderly or shut-in family members and friends. We serve elderly men whose wives have passed away and the surviving husband doesn't know how to cook (they never had to before). We serve people who live alone who are tired of eating a sandwich or a bowl of cereal for supper because cooking a wholesome meal for one is just too hard. We serve single parent families so mom or dad can go home after a full day's work to have good time and "take-out food" with their children. Little kids in struggling households think it's a treat because for just this little bit of time they get to be like the other kids by bringing dinner home.

Backus Community Cafe is a place where friendships form. Our guests make connections with one another and share happenings from their days. People tend to arrive at the same time each Tuesday or Thursday so they can visit with people they've befriended over time. Our guests know this is a safe place and they trust the staff and volunteers.

We have many organizations and individuals who call Backus asking to volunteer their service at Community Cafe. It is a very fulfilling evening of fellowship and purpose for our volunteers. There is a lot of food to be prepared and served, and we have people who want to help. They want to be involved. They want to be more aware of the happenings and changes in their community. I believe that the number of people wanting to volunteer at this meaningful program is growing because of the message that is seeping out into our community. Need is all around us. We need to start seeing differently. As a result, people are more understanding. People are more compassionate. Kindness is on the move. Our goal is to continue to serve this need in our community. We have made improvements to the quality of foods that are served and work to include fresh fruits as often as possible. We expect that this need for meals will continue into the unforeseeable future.


### Summer Food Service Program

The Summer Food Service Program (SFSP) that began in 2010 provides a free "school" type lunch to children ages 1-18 as well as to clients of the Falls Hunger Coalition and clients of Servants of Shelter. The program is sponsored, certified, and inspected by the MN Department of Education (MDE) and has specific guidelines for nutrition, portions and components of meals. The goal of the program is to provide nutritious meals to children when school is not in session. We served a record number of children in the 2021 summer program!

The program completed its 12th year in 2021. A free, nutritious meal was served Monday-Friday, 11:30am – 1:30pm during the months of June, July, and August. As families struggled to make ends meet at the onset of the pandemic, the Summer Food Service Program came with help. At a time of uncertainty and change, getting a good hot lunch at Backus was a constant, and word spread through the community quickly. This year was a banner year for the number of meals served; there were a total of 9,988 meals served in 2021. All meals continued to be served as "pick-up" only. Families picked up their meals at the east door of Backus and took lunch home for the kids. There was very positive feedback to this new process. Parents commented on how their children ate better when they were at home versus being in the dining room with many other children because there were fewer distractions. Working parents liked the summer program because it gave them more quality time to just be with their kids during their work day. Everyone liked the hot meals! At the end of the 2021 program, a survey showed that the kids still liked the taco in a bag lunch the best, followed by cheese burgers. The kids told us that they really liked all of the food selections. 2021 was truly a banner year!

Just like the Community Café program, the Summer Food Service Program was manned this year by a core group of Backus Staff and Volunteers. The Backus team thoroughly enjoyed getting to know the kids and families and were happy to be part of their days.

The Summer Food Service Program served a total of 9,988meals in 2021. Everyone is looking forward to the summer of 2022!
